AN ACT

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," increasing the portion of the fee received from learners' permits appropriated to the Department of Public Instruction for carrying out a standardized program of teaching safe driving of motor vehicles.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 717, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," amended November 21, 1959 (P. L. 1577), is amended to read:

Section 717. Operators' Licenses; Duplicate Registration or Operator's License Card.—

(a) The fee for issuing an operator's license to a person unable to produce satisfactory proof of having held a Pennsylvania operator's license, during any one of the three (3) years preceding application, shall be four dollars (\$4.00), which fee shall entitle the applicant for such license to receive a learner's permit, valid for ninety (90) days from date of issue, and if the examination shall have been passed during the ninety-day period, an operator's license for the current period not to exceed one (1) year from date of learner's permit or until the occurrence of the month of birth of the operator at the discretion of the secretary.

(b) The fee for renewal of an operator's license shall be two dollars (\$2.00) per year.

(c) The fee for a duplicate operator's license card or duplicate registration card shall be fifty cents $*(50\phi)$.

(d) As much of the fee received for each learner's permit as may be necessary, but not more than [two dollars (\$2.00)] three dollars (\$3.00), is hereby appropriated to the Department of Public Instruction for the purpose of paying authorized expenses incurred by that department in connection with carrying out a standardized program of teaching of safe driving of motor vehicles in the public schools and making authorized payments to school districts complying with such standardized program. Such moneys shall be paid out of the Motor License Fund upon the warrant of the

(e) The fee for renewal of the initial operator's license for the two (2) year license period may be prorated by the secretary.

Effective date.

Section 2. This act shall take effect on the first day of the month next following final enactment.

AN ACT

Authorizing the Commonwealth, through the Department of Forests and Waters, or other State agencies or instrumentalities, or political subdivisions of the Commonwealth, or other local public bodies, separately or together, to conduct surveys, make land use studies, and to purchase or accept land for park and recreational purposes, conservation purposes, preservation of open space land, and for historic and scenic purposes with the assistance of the Federal Government, and to accept funds, personnel or other aid from the Federal Government or from other sources.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Commonwealth, through the Department of Forests and Waters, or other State agencies or instrumentalities, or political subdivisions of the Commonwealth, or other local public bodies, separately or together, are hereby authorized to conduct surveys, make land use studies, and purchase or accept land for park and recreation purposes, for conservation of land and other natural resources, for the preservation of open space land, and for historic and scenic purposes with the assistance of the Federal Government under the Federal Housing Act of 1961 or amendments thereto or other similar Congressional enactments, and for this purpose are hereby authorized to accept and utilize funds, personnel or other aid from the Federal Government or any of its agencies, or from any other sources, public or private.
