Section 907. Appropriation.—So much of the \*moneys received as payment of tax under this act as shall be necessary for the payment of the refunds provided for in this act is hereby appropriated for the payment of such refunds.

Effective date.

Section 2. This act shall take effect January 1, 1962.

## No. 661

## A SUPPLEMENT

To the act of April 1, 1863 (P. L. 213), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making an appropriation for carrying the same into effect.

Agricultural Colleges.

Act of Congress, approved July 2, 1862, with amendments, and act of April 1, 1863, P. L. 218, in acceptance by Pennsylvania, effectuated by appropriations of specific amounts to applicable institutions for certain purposes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. In order to carry into effect the act of Congress, approved July 2, 1862, granting public land to the several states for educational purposes and subsequent acts of Congress related thereto, and the act of the Legislature of Pennsylvania accepting the provisions and conditions of said acts of Congress and pledging the faith of the State to carry the same into effect, the sum of eighteen million five hundred seventeen thousand seven hundred sixty \*\*dollars (\$18,517,760), or as much thereof as may be necessary, is hereby specifically appropriated to the trustees of the Pennsylvania State University for the fiscal period June 1, 1961, to June 30, 1962, for the following purposes:

(1) For the general maintenance of instruction, research and extension in the College of Agriculture, the Mont Alto State Forest School, the College of Business Administration, the College of Engineering and Architecture, the College of Liberal Arts, the College of Home Economics, the College of Mineral Industries, the College of Chemistry and Physics, the College of Education, the Graduate School, the College of Physical Education and Athletics, the General Extension Services, and for the general maintenance of other schools, departments, offices and services, including repairs and improvements to the grounds and buildings, service of light, heat, power, water and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest, and such other ex-

penditures as the trustees may deem necessary and practicable, the sum of eighteen million two hundred fifteen thousand four hundred sixty dollars (\$18,-215,460).

- (2) For the purpose of carrying on research and investigation to discover by-products of anthracite and bituminous coal and uses therefor, of developing new scientific, chemical, industrial, domestic and other uses and new and extended markets for anthracite coal and its products, and for employing engineers, chemists, technical experts, assistants, clerks, stenographers and other employes, and purchasing such machinery, supplies, equipment, apparatus and other things necessary in the furtherance of the aforesaid research and investigation to be used by the College of Mineral Industries under the supervision of the State Department of Mines and Mineral Industries, the sum of thirty-seven thousand eight hundred dollars (\$37,800). The moneys appropriated by this clause shall be available and expended only to the extent that a sum equal to fifty per centum of the amount to be expended by the Commonwealth is contributed to the Pennsylvania State University by the members of the anthracite and bituminous coal industry. Affidavits evidencing such contributions shall be submitted by the University to the Auditor General.
- (3) For the purpose of matching money contributed by industry to the College of Mineral Industries for research and investigation of long-range problems affecting the mineral industries, the sum of thirty-one thousand and fifty dollars (\$31,050). No more shall be expended from this item than may be required to match an equal sum contributed to the University by one or more industries for such research and investigation. Affidavits evidencing such contributions shall be submitted by the University to the Auditor General.
- (4) The support of research and investigation of basic problems affecting the slate and other nonmetallic mineral industries, the sum of eighteen thousand nine hundred dollars (\$18,900).
- (5) For the support of research and investigation of long-range basic problems affecting the mineral industries, the sum of seventeen thousand five hundred fifty dollars (\$17,550).
- (6) For the use of the College of Agriculture for expenditure by the Agricultural Experiment Station for the support of research and investigation directed toward the development and production of superior strains of crops and livestock and to develop more efficient methods of producing and marketing such

products, the sum of eighty-one thousand dollars (\$81,000).

- (7) For the maintenance and the support of research and experimental investigation on problems relating to the petroleum industry of the State, the sum of fifty-four thousand dollars (\$54,000).
- (8) For the use of the School of Agriculture, for expenditure by the Agriculture Experiment Station for the erection of experimental mushroom houses and research in the communicable diseases of mushrooms and other phases of the mushroom industry, the sum of twenty-five thousand dollars (\$25,000).
- (9) For the use of the School of Agriculture, for expenditure by the Agricultural Experiment Station for research and investigation of mastitis in dairy cattle, the sum of twenty-seven thousand dollars (\$27,000).
- (10) For the use of the School of Forestry for the purpose of conducting research on diseases of maple trees in Pennsylvania, the sum of ten thousand dollars (\$10,000).

## No. 662

## AN ACT

Amending the act of June 22, 1935 (P. L. 414), entitled, as amended, "An act to provide revenue for State purposes; imposing taxes upon certain classes of personal property; providing for the assessment, collection, and lien of the same, and the distribution of the proceeds thereof; imposing duties on executors, administrators, registers of wills, recorders of deeds, prothonotaries, and court clerks, and on persons, copartnerships, associations, banks, national banks, trust companies, and other corporations receiving deposits of money, and on certain corporations and limited partnerships; conferring powers and imposing duties on certain State officers and departments; imposing penalties; and making an appropriation," providing that certain corporations doing business with professional school employes shall not be subject to the provisions of the act.

State Personal Property Tax Act.

Section 17, act of June 22, 1935, P. L. 414, reenacted and amended July 11, 1941, P. L. 361, and amended May 28, 1945, P. L. 1083, further amended.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 17, act of June 22, 1935 (P. L. 414), known as the "State Personal Property Tax Act," reenacted and amended July 11, 1941 (P. L. 361) and amended May 28, 1945 (P. L. 1083), is amended to read:

Section 17. State Tax on Scrip, Bonds, Et Cetera; Imposition and Rate of Tax.—All scrip, bonds, certificates, and evidence of indebtedness issued, and all
