(b) In the case of a contributor who is a member of Class T-A with credit for multiple service, the present value of the State annuity shall be multiplied by the ratio determined by dividing the number of voluntary withdrawal credits to his credit at the date of death by one hundred (100), unless the number of voluntary withdrawal credits which he would have to his credit had he continued in service until superannuation retirement age is less than one hundred (100), in which case, such lesser number of withdrawal credits shall be substituted for one hundred (100) in the denominator of the ratio.

(3) Should a contributor who is not eligible for retirement in accordance with the provisions of subsections (1), (2) and (2.1) of this section die [before becoming eligible for a superannuation retirement allowance by reason of having attained superannuation retirement age or a withdrawal allowance by reason of having twenty-five (25) years of credited service before retirement, his accumulated deductions shall be paid to his estate or to such person as he shall have nominated by written designation, duly executed and filed with the retirement board.

#### AN ACT

Amending the act of June 24, 1939 (P. L. 872), entitled "An act to consolidate, amend and revise the penal laws of the Commonwealth," prohibiting certain business activities on Sunday.

Section \*699.15. Selling or Otherwise Dealing in Fresh Meats, Produce and Groceries on Sunday.—Whoever engages in the business of selling or otherwise dealing at retail in fresh meats, produce and groceries on Sunday shall, upon conviction thereof in a summary proceeding for the first offense, be sentenced to pay a fine of not exceeding one hundred dollars (\$100), and for the second or any subsequent offense committed within one (1) year after conviction for the first offense, be sentenced to pay a fine of not exceeding two hundred dollars (\$200) or undergo imprisonment not exceeding thirty (30) days in default thereof.

Each separate sale, or offer to sell, shall constitute a

separate offense.

Informations charging violations of this section shall be brought within seventy-two (72) hours after the com-

mission of the alleged offense and not thereafter.

This section shall not apply to any retail establishment employing less than ten persons or to any retail establishment where fresh meats, produce and groceries are offered or sold by the proprietor or members of his immediate family or employing less than ten persons nor shall it apply to any retail establishment where food is prepared on the premises for human consumption.

Effective date.

Section 2. This act shall take effect in thirty days.

## No. 697

### AN ACT

Limiting the liability of landowners of agricultural lands or woodlands for personal injuries suffered by any person while hunting or fishing upon the landowner's property.

Limitation of liability in certain cases.

Landowner not liable in damages for personal injury to hunters and fishermen, except wilfully inflicted by landowner.

Act effective immediately.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. No landowner of agricultural lands or woodlands shall be liable for the payment of damages for any personal injury suffered by any person while hunting or fishing upon the landowner's property, except for any deliberate and wilful personal injury inflicted upon such person by such landowner.

Section 2. This act shall take effect immediately.
