five registered electors of the township, who shall be styled township supervisors.

## AN ACT

Amending the act of April 14, 1834 (P. L. 333), entitled "An act relative to the organization of the Courts of Justice," prohibiting judges from receiving any fee or emolument for performing the duties of an arbitrator.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The act of April 14, 1834 (P. L. 333), entitled "An act relative to the organization of the Courts of Justice," is amended by adding, after section 75, a new section to read:

Section 75.1. No judge of a court of record of this Commonwealth shall, during his term of office, receive any fee or emolument for the performing of the duties of an arbitrator in any case in which arbitration is required or authorized for the settlement of adverse rights or duties by statute or rule of court, or is agreed upon by the parties for the settlement of any dispute which is not before a court of record for determination.

Section 2. This act shall take effect immediately.

Section 513, act of April 9, 1929, P. L. 177, amended. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 513, act of April 9, 1929 (P. L. 177), known as "The Administrative Code of 1929," is amended to read:

Section 513. Acceptance of Gifts or Donations.— Every administrative department, every independent administrative board and commission, and, with the approval of the department with which it is connected, every departmental administrative board or commission, may accept gifts or donations of money, securities, or other personal property, which, or the income of which, shall be used in conducting the work of such department, board, or commission, or for the benefit of the inmates or patients of any State institution administered by such department, board, or commission.

[Except] The Department of Property and Supplies, with the approval of the Governor, may accept for educational purposes on behalf of the Commonwealth real estate, or any interest in real estate, by deed, gift or devise, upon investigation and approval of the title thereto by the Department of Justice, and except as otherwise in this act expressly provided, a department, board, or commission, shall not accept any gift of real estate, or of any interest in real estate, without specific authority from the General Assembly so to do.
