Secretary of Highways, twenty thousand dollars (\$20,000).

Secretary of Health, twenty thousand dollars (\$20,000).

Commissioner of the Pennsylvania State Police, twenty thousand dollars (\$20,000).

Deputy Commissioner of the Pennsylvania State Police, thirteen thousand five hundred dollars (\$13,500).

Secretary of Labor and Industry, twenty thousand dollars (\$20,000).

Secretary of Public Welfare, twenty thousand dollars (\$20.000).

Secretary of Revenue, twenty thousand dollars (\$20,000).

Secretary of Public Assistance, twenty thousand dollars (\$20.000).

Secretary of Commerce, twenty thousand dollars (\$20,000).

Neither the Governor, Lieutenant Governor nor the head of any administrative department shall receive any additional compensation for any services rendered to the Commonwealth in any capacity.

Section 2. This act shall take effect July 1, 1963. Effective date.

AN ACT

Amending the act of May 1, 1933 (P. L. 103), entitled "An act concerning townships of the second class; and amending, revis-ing, consolidating, and changing the law relating thereto," further regulating the compensation of township secretaries and treasurers.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 531, act of May 1, 1933 (P. L. 103), known as "The Second Class Township Code," reenacted and amended July 10, 1947 (P. L. 1481) and amended June 1, 1956 (P. L. 2021), is amended to read:

Section 531. Compensation.—The township treasurer shall receive, as compensation for his services, salary, wages or a certain percentage on all moneys received and paid by him, which [rate] compensation shall be determined by the supervisors of the townships.

LAWS OF PENNSYLVANIA,

Except as otherwise provided in section 540 hereof, the amount paid to the treasurer as treasurer and secretary, shall not exceed three per centum of the money paid out by the treasurer, but it shall not be less than fifty dollars; and the calculation of such maximum compensation shall not include any percentage upon money paid out by the treasurer for the repayment of loans, notes, certificates, or other evidences of indebtedness, or other borrowed moneys.

Section 2. Section 540 of the act, amended September 22, 1961 (P. L. 1594), is amended to read:

Section 540. Duties and Compensation.—The secretary in each township shall be clerk to the board of supervisors. He shall keep a record of the proceedings of said officers in a minute book in which he shall also record all court orders relative to the laying out, opening, and vacating of roads. The minute book, account book and other financial records shall be carefully preserved by the secretary and shall be turned over to his successor in office. Miscellaneous records and papers of the township other than the minute book and account book may be destroyed with the consent of the supervisors after the lapse of six years from the date of such records.

The secretary shall prepare and write the annual tax duplicate of the township, and shall receive such salary, wages or other compensation therefor as shall be fixed by the township supervisors. The combined amount paid to the secretary and treasurer as salary, wages or other compensation for services, exclusive of the compensation for the preparation of the annual tax duplicate, shall not exceed three per centum of the money paid out by the treasurer, but it shall not be less than fifty dollars; and the calculation of such maximum compensation shall not include any percentage upon moneys paid out by the treasurer for the repayment of loans, notes, certificates, or other evidences of indebtedness, or other borrowed moneys.

The secretary shall inform all members of the board of supervisors of all functions and meetings, including special meetings of the board.

Act effective immediately.

Section 3. This act shall take effect immediately.
