AN ACT

Amending the act of June 23, 1931 (P. L. 932), entitled "An act relating to cities of the third class; and amending, revising, and consolidating the law relating thereto," adding the Veterans of World War I of the U. S. A., Inc.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Clause 34 of section 2403, act of June 23, 1931 (P. L. 932), known as "The Third Class City Code," reenacted and amended June 28, 1951 (P. L. 662), amended June 7, 1961 (P. L. 253), is amended to read:

Section 2403. Specific Powers.—In addition to other powers granted by this act, the council of each city shall have power, by ordinance:

.

34. Appropriations to Post of Veterans.—To appropriate annually to each camp of the United States War Veterans in the city, and to each post of the American Legion, and to each post of the Veterans of Foreign Wars, and to each post of the Veterans of World War I of the U.S.A., Inc., and to each post of the American Veterans of World War II (AMVETS), to each post of the Catholic War Veterans, Inc., and to each detachment of the Marine *Corps League, and to each Naval Association, and to each post of the Grand Army of the Republic, and to each post of the Disabled American Veterans of the World War, and to each chapter of the Military Order of the Purple Heart, and to each post of the Jewish War Veterans, and to each organization of American Gold Star Mothers, and to each post of the Italian American War Veterans of the United States. Incorporated, and to any other such organization of exservice men in the city, incorporated under the laws of the Commonwealth, a sum not to exceed three hundred dollars, to aid in defraying the expenses of Memorial Day and Armistice Day. Where the Grand Army of the Republic has ceased to exist or to function, such appropriation may be made to the Sons of Union Veterans of

the Civil War, or, in the absence of such order, to a duly constituted organization which conducts the decorating of the graves of Union veterans of the Civil War. Such payments shall be made to defray actual expenses only. Before any payment is made, the organization receiving the same shall submit verified accounts of their expenditures.

AN ACT

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," adding the Veterans of World War I of the U. S. A., Inc.

The Vehicle Code.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (a) of section 729, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," amended June 21, 1961 (P. L. 499) and September 2, 1961 (P. L. 1151), is amended to read:

Section 729. Exemptions from Fees .--

(a) No fee shall be charged for a certificate of title or registration of motor vehicles, tractors, fire department equipment, trailers and semi-trailers owned by and used exclusively in the performance of the duties of (1) the Federal Government, (2) any state, other than Pennsylvania, which issues titles or registrations to this Commonwealth without charge, (3) the Commonwealth of Pennsylvania, (4) any city, borough, incorporated town, township, county, county institution district or school district of this Commonwealth, (5) the Civil Air Patrol and duly authorized volunteer fire force, in the extinguishment and prevention of fires or in rescue work, hospital, humane society, or anticruelty society in this Commonwealth, (6) the American Red Cross, (7) churches, (8) Girl Scouts of America, (9) Boy Scouts of America, (10) Salvation Army, (11) duly chartered post organization or combination of organizations of the American Legion, Veterans of Foreign Wars, Philippine Pacific War Veterans, Navy Club of the
