Bridges.

Secretary of Highways authorized to construct a new bridge between Mount Union Borough, Huntingdon County, and Wayne Township, Mifflin County.

Powers of Department of Highways, including eminent domain. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Secretary of Highways is hereby requested to construct a new bridge, replacing the present structure crossing the Juniata River on Route 44018, connecting the Borough of Mount Union in Huntingdon County and Wayne Township in Mifflin County near Kistler Borough.

Section 2. In the construction of said bridge and the approaches thereto and connections with State highways, the Department of Highways shall have all of the powers and authority conferred with respect to the relocation, widening or construction of State highways, including the exercise of the power of eminent domain. Any damages sustained by reason of taking property in the construction of such bridge, the approaches thereto and connections with State highways, shall be ascertained in accordance with laws applicable to the ascertainment of damages in relocating, widening or constructing State highways, and such damages, when ascertained, shall be paid by the Commonwealth or county or counties as may be agreed upon in accordance with the laws relating to State highways.

The Department of Highways shall have authority to make and carry out and to do every other act necessary to carry out the project herein authorized.

Upon completion. duty of Department of Highways to maintain.

Appropriation from Motor License Fund.

Section 3. After the completion of such highway, bridge and the approaches thereto, they shall be reconstructed and maintained by the Department of Highways in accordance with present or future laws governing the reconstruction and maintenance of State highways.

Section 4. So much of the money in the Motor License Fund from time to time as may be needed to carry out the provisions of this act, but not in excess of one hundred forty thousand dollars (\$140,000), is hereby specifically appropriated to the Department of Highways for such purposes.

## AN ACT

Amending the act of June 3, 1937 (P. L. 1333), entitled "An act concerning elections, including general, municipal, special and primary elections, the nomination of candidates, primary and

election expenses and election contests; creating and defining membership of county boards of elections; imposing duties upon the Secretary of the Commonwealth, courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to elections," requiring a complete accounting of all receipts and disbursements of political committees.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (a) of section 1607, act of June 3, 1937 (P. L. 1333), known as the "Pennsylvania Election Code," amended April 21, 1949 (P. L. 693), is amended to read:

Section 1607. Expense Accounts to Be Filed.—

(a) Every candidate for nomination or election, and every treasurer of a political committee, or person acting as such treasurer, shall, within thirty days after every primary and election at which such candidate was voted for or with which such political committee was concerned, if the amount received or expended or liabilities incurred shall exceed the sum of one hundred fifty dollars, file a full, true and detailed account, subscribed and sworn to by him, setting forth each and every sum of money received, contributed or disbursed by him for primary or election expenses, the date of each receipt, contribution and disbursement, the name of the person from whom received or to whom paid, and the specific object or purpose for which the same was disbursed. Such account shall also set forth the unpaid debts and liabilities of any such candidate or committee for primary or election expenses, with the nature and amount of each, and to whom owing. In the case of the treasurer of a political committee, the account shall include any unexpended balance of contributions or other receipts appearing from the last previous account filed by him, and shall also include a complete listing of all receipts and disbursements made by such committee for any purpose, including all receipts and disbursements from the publication and sale of all publications, and from the time of the last account or from the time of the formation of the political committee if no prior account has been filed. In the case of candidates for election who have previously filed accounts of their primary expenses as candidates for nomination, the accounts shall only include receipts. contributions and disbursements subsequent to the date of such prior accounts.
