of the Chief Justice and judges of the Supreme Court, the President Judge and judges of the Superior Court, the judges of the courts of common pleas, the judges of the orphans' courts, the judges of the Municipal Court of Philadelphia and the judges of the County Court and Juvenile Court of Allegheny County, certain associate judges not learned in the law, certain state officers, and the salary and expenses of the members of the General Assembly, and repealing certain inconsistent acts."

Election and term.

Section 2. At the next municipal election in November, 1965, the qualified electors of the fiftieth judicial district shall elect, in the same manner prescribed by law for the election of the president judge of the court of common pleas of the district, a competent person learned in the law to serve as additional law judge of the court of common pleas of the fiftieth judicial district from the first Monday in January, 1966, for a term of ten years. Vacancies in the office hereby created whether caused by death, resignation, expiration of term or otherwise shall be filled in the same manner as is required by law in case of a similar vacancy in the office of president judge of the court.

Appointment.

Section 3. The Governor may appoint a competent person, learned in the law, as additional law judge of the court of common pleas of the fiftieth judicial district to serve until the first Monday of January, 1966.

Effective date.

Section 4. This act shall take effect November 15, 1963.

## No. 265

#### AN ACT

Establishing a separate orphans' court in and for the County of Bucks.

Judges of Orphans' Court. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Orphans' Court established in Seventh Judicial District, Bucks County. Section 1. Pursuant to the provisions of Article V., section 22 of the Constitution of the Commonwealth of Pennsylvania, which provides that a separate orphans' court shall be established by the General Assembly in any county wherein the population shall exceed one hundred and fifty thousand, a separate orphans' court is established in the Seventh Judicial District composed

of the County of Bucks. The name and style shall be the Orphans' Court of Bucks County.

Section 2. The court shall be a court of record and Court of record. shall consist of one judge learned in the law. The terms of the orphans' court shall be established by the judge thereof as he shall deem necessary and proper.

Section 3. The court hereby created shall have and Powers. exercise all the jurisdiction and powers now vested in, or which may hereafter be conferred upon, the orphans' courts of this Commonwealth under and by virtue of the laws thereof.

Section 4. The county commissioners of said county shall provide proper and suitable rooms in which the orphans' court shall be held and its business transacted and in which the records thereof shall be safely and securely kept.

Duty of county commissioners to provide courtrooms, etc.

Section 5. At the municipal election to be held in 1965, a judge of the orphans' court shall be elected and duly commissioned to hold office from the first Monday of January next succeeding such election for the same term and in the same manner as the judges of the court of common pleas of the county. The annual salary of said judge and the manner of payment shall be the same as is paid to the judges of the court of common pleas of said county.

Election.

Section 6. The Governor is hereby authorized to appoint one competent person, learned in the law, as judge of said orphans' court to serve until the first Monday of January next succeeding the municipal election to be held in 1965.

Interim appointment.

Effective date. Section 7. This act shall take effect November 15. 1963.
