(50,000), four thousand seven hundred dollars (\$4,700). The annual salary of each county commissioner shall

be three thousand four hundred dollars (\$3,400).

The jury commissioners shall each receive twelve dollars and fifty cents (\$12.50) for each day necessarily employed in the discharge of their duties. The said compensation shall be paid from the county treasury in the same manner as the salary or compensation of other county officers and employes.

The county auditors shall receive [twelve dollars and fifty cents (\$12.50)] fifteen dollars (\$15.00) for each day necessarily employed in the discharge of their duties, together with [six cents (6ϕ)] ten cents (10ϕ) per mile circular from and to their homes, once, each and every

day so employed.

This act shall become effective and applicable to all county auditors in counties of the seventh class who shall be elected or appointed after the effective date of this act.

AN ACT

Amending the act of May 21, 1956 (P. L. 1642), entitled "An act to promote the welfare of the people of the Commonwealth; creating a body corporate and politic to be known as the Commonwealth Mental Health Research Foundation for the purpose of supporting, encouraging and financing research in the field of mental health; providing for the administration and operation of the Foundation," providing for additional trustees, changing provisions relating to meetings, and making editorial

Commonwealth Mental Health Research Foundation Act.

Sections 5 and 6, act of May 21, 1956, P. L. 1642, amended.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Sections 5 and 6, act of May 21, 1956 (P. L. 1642), known as the "Commonwealth Mental Health Research Foundation Act," are amended to read:

Section 5. Board of Trustees.—(a) The Foundation shall be administered by a board of [eleven (11)] fifteen (15) trustees consisting of the Governor, the Secretary of Public Welfare, the Commissioner of Mental Health and [nine (9)] twelve (12) trustees appointed by the Governor for terms of three (3) years each and until their respective successors shall be duly appointed and qualified. Of the original appointed trustees the terms

- of three (3) shall expire on December 31, 1957, the terms of three (3) shall expire on December 31, 1958, and the terms of three (3) shall expire on December 31, 1959. Of the three (3) additional appointed trustees, the term of one (1) shall expire December 31, 1964, the term of one (1) shall expire December 31, 1965, and the term of one (1) shall expire December 31, 1966. Any trustee may be reappointed. Any person appointed to fill a vacancy shall serve for the unexpired term.
- (b) The members of the board shall not be entitled to any compensation for their services as members.
- (c) [Six (6)] Eight (8) members of the board shall constitute a quorum and any action taken by a majority of a quorum present at a duly convened meeting of the board shall be the legal action of the board.
- (d) The Secretary of *Public* Welfare shall be the chairman of the board and the Foundation shall have such other officers as the board deems necessary.
- (e) The board shall meet regularly at least [once each month] three times each year and specially upon the call of the chairman.

Section 6. Research Advisory Committee.-The Secretary of Public Welfare shall appoint a Research Advisory Committee of nine (9) members, one of whom shall be the Commissioner of Mental Health, who shall be its chairman. In appointing such Committee, the Secretary of Public Welfare shall select one representative from each of the following six (6) medical schools, colleges or mental institutions having an active research department: The School of Medicine of Temple University, the School of Medicine of the University of Pennsylvania, the Pennsylvania State University, the School of Medicine of the University of Pittsburgh, the Eastern Pennsylvania Psychiatric Institute and Carnegie Institute of Technology. The Research Advisory Committee, subject to approval of the board, shall choose and supervise the projects to be undertaken by the Foundation. The members of the Research Advisory Committee shall not be entitled to any compensation for their services as members but shall be entitled to reimbursement for all necessary expenses incurred in connection with the performance of their duties as members. The programs of research and of training men in the field of mental health shall be carried out only in Commonwealth institutions under the jurisdiction of the Department of Public Welfare: Provided, however, That this section shall not be construed to prevent ancillary research or training outside of these institutions so long as the primary program in connection with such ancillary research or training is undertaken is conducted within a Commonwealth institution.

AN ACT

Amending the act of March 10, 1949 (P. L. 30), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," providing for the cost of tuition of children who are socially or emotionally disturbed and removing certain limitations relative to special education for children afflicted with cerebral palsy.

Public School Code of 1949. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1376, act of March 10, 1949, P. L. 30, amended by adding a new subsection (c). Section 1. Section 1376, act of March 10, 1949 (P. L. 30), known as the "Public School Code of 1949," is amended by adding, at the end thereof, a new subsection to read:

Section 1376. Cost of Tuition and Maintenance of Certain Exceptional Children in Approved Institutions.

(c) When any child between the ages of six (6) and twenty-one (21) years of age, resident in this Commonwealth, who is socially or emotionally disturbed, is enrolled with the approval of the Department of Public Instruction as a pupil in any approved day school under supervision of or approved by the Department of Public Instruction, the school district in which such child is resident shall pay twenty-five per cent (25%) of the cost of tuition of such child in such school as determined by the Department of Public Instruction, and the Commonwealth shall pay out of funds appropriated to the department for special education seventy-five per cent (75%) of the cost of tuition of such child as determined by the department: Provided, however, That in no event shall the cost of tuition of such child exceed one thousand dollars (\$1000) per school year.
