Section 1986. Appropriations to Tourist Promotion Agencies.—The board of commissioners may appropriate, annually, such amount of money but not in excess of ten cents (10¢) for each resident of the county, as determined by the last census, which may be deemed necessary to any "tourist promotion agency" as defined in the act of April 28, 1961 (P. L. 111), known as the "Tourist Promotion Law," to assist such agencies in carrying out tourist promotional activities.

### AN ACT

Amending the act of August 31, 1955 (P. L. 531), entitled "An act permitting and regulating wrestling and boxing contests and exhibitions; requiring licenses and permits; conferring powers and imposing duties upon the State Athletic Commission; providing for the granting, suspension, and revocation of licenses and permits issued by the Commission; preserving the rights of existing licensees and permittees; prescribing penalties, fines, forfeitures and misdemeanors; requiring bonds and insurance; creating a Medical Advisory Board; providing

for rules and regulations; and making appropriations," prohibiting the issuance of licenses to certain persons adjudged guilty of certain crimes.

Pennsylvania Athletic Code.

Act of August 31, 1955, P. L. 531, amended by adding a new section 311.1. The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The act of August 31, 1955 (P. L. 531), known as the "Pennsylvania Athletic Code," is amended by adding, after section 311, a new section to read:

Section 311.1. Prohibited Licenses.—The Commission shall not issue or renew a promoter's or manager's license to any person who has been convicted or pleaded guilty or nolo contendere to any of the following offenses during the ten years preceding the date of application:

Bribery, Corrupt solicitations, Extortion, Perjury and subornation of perjury, Carrying deadly weapons, All offenses enumerated in Article V of The Penal Code of 1939, Bribery in athletic contests, Soliciting or accepting a bribe in athletic contests, Blackmail, Professional thief, Murder, Administering drugs, Rape. Assault with intent to ravish, Kidnapping, All offenses involving the use, sale or delivery of

### AN ACT

Amending the act of August 10, 1951 (P. L. 1163), entitled, as amended, "An act relating to the orphans' court; conferring exclusive jurisdiction on such courts over the administration and distribution of decedents' estates, trust estates, minors' estates, absentees' estates and incompetents' estates and the determination of title to real estate in certain cases; providing for the organization of orphans' courts, the procedure therein, the powers and duties of the judges thereof, and appeals therefrom," to permit the appearance of a taxing authority as a party in interest in certain cases.
