## AN ACT

SB 455

Amending the act of June 22, 1931 (P. L. 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways, and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," deleting a route in Mercer County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Route 43068, established by the act of June 22, 1931 (P. L. 594), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance, and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," and its amendments, is deleted as follows:

## Mercer County

[Route 43068. Beginning at State Route 446 at Carpenters Corners; and running east in New Vernon Township, past the Voorhies School, through McQuiston Corners, to a point on the dividing line between New Vernon and Sandy Lake Townships; thence east and southeast in Sandy Lake Township, via Donley Crossroads, to a point on the north boundary line of Sandy Lake Borough, in Mercer County, a distance of about 6.0 miles.]

Section 2. This act shall take effect immediately.

AN ACT

HB 432

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 1.46 acres, more or less, of land situate in Vernon Township, Crawford County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania, to sell at public sale to the highest bidder, the following described tract of land situate in the Township of Vernon, County of Crawford and Commonwealth of Pennsylvania, bounded and described as follows:

Beginning at a post in the south line of Henderson Avenue 50 feet easterly from the easterly building line of a public alley, thence south 66 degrees 54 minutes east along the southerly building line at Henderson Avenue 150 feet to the westerly building line of Clay Street; thence south 17 degrees 52 minutes west along the west line of Clay Street 320.78 feet to the northerly building line of Mill Street; thence north 66 degrees 54 minutes west along the north line of Mill Street 248.64 feet to the easterly building line of public alley; thence north 26 degrees 32 minutes west along the easterly building line of said public alley 160 feet to a post; thence south 66 degrees 54 minutes east along the land now or late of Clara Thibaut 50 feet to a post; thence north 26 degrees 32 minutes east along the land now or late of Clara Thibaut 160 feet to the place of beginning and containing 1.46 acres, more or less.

The conveyance shall be made under and subject, nevertheless, to all easements, servitudes and rights of others, including but not confined to streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipe line companies as well as under and subject, nevertheless, to any estate or tenancies vested in third persons whether or not appearing of record for any portion of the said land or improvements erected thereon.

Section 2. The deed of conveyance shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania.

Section 3. All moneys received from the sale of the land herein authorized to be conveyed shall be deposited in the Motor License Fund.

Section 4. This act shall take effect immediately.
