HB 552

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," changing the penalty for operating any motor vehicle or tractor without a license as an operator or learner and adding a penalty for violation of a restriction noted on the license.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 601, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," amended August 27, 1963 (P. L. 1353), is amended to read:

Section 601. Operators Must Be Licensed.—(a) No person, except those expressly exempted under this act, shall operate any motor vehicle or tractor upon a highway in this Commonwealth, unless such person has been licensed as an operator or a learner by the department under the provisions of this act. [No person who has been issued a restricted license to operate motor vehicles or tractors by the secretary shall operate any motor vehicle or tractor in violation of such restrictions.]

Penalty.—Any person violating any of the provisions of subsection (a) of this section, shall, upon summary conviction before a magistrate for a first offense be sentenced to pay a fine of [twenty-five dollars (\$25.00)] fifty dollars (\$50.00) and costs of prosecution, and, in default of the payment thereof, shall undergo imprisonment for not more than [five (5)] ten (10) days, and for the second and any subsequent offense, shall be guilty of a misdemeanor, and, upon conviction thereof in a court of quarter sessions, shall be sentenced to pay a fine of not less than one hundred dollars (\$100) and not more than five hundred dollars (\$500) and costs of prosecution, or to undergo imprisonment for not more than three (3) years, or both such fine and imprisonment.

No person charged with violating this [section] subsection (a) shall be convicted if he produces in court or at the office of the arresting officer an operator's license or learner's permit theretofore issued to him and valid in Pennsylvania at the time of his arrest.

(b) No person who has been issued a restricted license to operate motor vehicles or tractors by the secretary shall operate any motor

vehicle or tractor in violation of such restrictions.

Penalty.—Any person violating the provisions of subsection (b) of this section shall upon summary conviction before a magistrate be sentenced to pay a fine of ten dollars (\$10.00) and costs of prosecution, and, in default of payment thereof, shall undergo imprisonment for not more than five (5) days.

Section 2. This act shall take effect immediately.

SB 411

Providing for the incorporation as public instrumentalities of the Commonwealth and as bodies corporate and politic of industrial development authorities for municipalities, counties and townships; prescribing the rights, powers and duties of such authorities hereafter incorporated; authorizing such authorities to acquire, by gift or purchase, to construct, improve and maintain industrial development projects, and to borrow money and issue bonds therefor; providing for the payment of such bonds and giving security therefor, and prescribing the rights of the holders of such bonds; authorizing the lease or sale of industrial development projects to industrial, manufacturing or research and development enterprises; authorizing any county, municipality or township to transfer or convey to such authorities, any facilities or property available for industrial development projects; exempting the property and securities of such authorities from taxation; authorizing such authorities to enter into contracts with and to accept grants from the Federal Government or any agency thereof; and providing for approval by the Secretary of Commerce of the proceedings relating to industrial development projects of such authorities.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. This act shall be known and may be cited as the "Industrial Development Authority Law."

Section 2. Findings and Declaration of Policy.—It is hereby determined and declared as a matter of legislative finding:

(1) That economic insecurity due to unemployment is at any time a serious menace to the health, safety, morals and general welfare of the people of the Commonwealth and that a high level of unemployment and lack of business opportunity are threats to the strength and permanence of American political and economic institutions and the philosophy of freedom on which those institutions are based;

(2) That a minimum level of unemployment and a maximum level
