paid therefor, may sue in assumpsit on said additional bond, in the name of the borough, for his, their or its use and prosecute the same to final judgment for such sum or sums as may be justly due him, them, or it and have execution thereof; provided, the borough shall not be liable for the payment of any costs or expense of any suit.

Section 3. This act shall take effect immediately.
