Designating a certain bridge connecting Chester and Montgomery Counties as the Spring-Ford Veterans' Memorial Bridge.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The new bridge crossing the Schuylkill River, between Spring City in Chester County and Royersford in Montgomery County, is hereby officially designated and shall be known as the "Spring-Ford Veterans' Memorial Bridge" in honor of the thousands of men and women from that area who have served their country so well.

Section 2. This act shall take effect immediately.

HB 323

Amending the act of April 29, 1959 (P. L. 58), entitled "An act consolidating and revising the Vehicle Code, the Tractor Code, the Motor Vehicle Financial Responsibility Act and other acts relating to the ownership, possession and use of vehicles and tractors," further providing for the fee for certain police records and requiring the Commissioner of State Police to furnish the copy of the Pennsylvania State Police full report of investigation to certain persons and governmental agencies or to refuse to furnish such records in certain cases of pending criminal charges.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Sections 722.1 and 1217.1, act of April 29, 1959 (P. L. 58), known as "The Vehicle Code," added November 19, 1959 (P. L. 1518), are amended to read:

Section 722.1. Fee for Pennsylvania State Police Record.—The fee for a certified [abstract of a] Pennsylvania State Police record of investigation of vehicle accidents, which the Pennsylvania State Police are authorized by this act to furnish to the public, shall be [three dollars (\$3.00)] five dollars (\$5.00) for each [form or supporting

document comprising such record.] copy of the Pennsylvania State Police full report of investigation.

Section 1217.1. [Abstract of] Record of Investigation.—The Commissioner of State Police shall, upon request, furnish [any person] a certified [abstract of the record] copy of the Pennsylvania State Police full report of investigation of any vehicle accident [. Said abstract shall be limited to the date, time, location, weather conditions, names and addresses of operators, passengers and witnesses, and a description of the vehicles involved] to any person involved in the accident, his attorney or insurer, and to the Federal government, branches of the military service, agencies of the Commonwealth of Pennsylvania, and to officials of counties, cities, boroughs, towns, and townships, and to agencies of other states and nations and their political subdivisions. Such [abstract] copy shall not be admissible as evidence in any action for damages or criminal proceedings arising out of a motor vehicle accident. The Commissioner of the Pennsylvania State Police may refuse to furnish such complete copy of investigation of the vehicle accident whenever there are criminal charges pending against any persons involved in the vehicle accident.

Amending the act of August 9, 1955 (P. L. 323), entitled "An act relating to counties of the third, fourth, fifth, sixth, seventh and eighth classes; amending, revising, consolidating and changing the laws relating thereto," changing the compensation of auditors in counties of the sixth, seventh and eighth classes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. So much of sections 1553, 1554 and 1555 as relates to county auditors, act of August 9, 1955 (P. L. 323), known as "The County Code," added January 25, 1966 (P. L. 1556), are amended to read:
