obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," is amended to read:

Route 02158. Beginning at a point on Route 70 [near] at the intersection of Oregon Avenue, thence in a northwesterly direction over Oregon Avenue to its intersection with Carlisle Street, thence in a southwesterly direction over Carlisle Street to its intersection with Pleasantville Road [and extending in a northwesterly direction to a point near Little Bull Creek;] thence in a northwesterly then northeasterly direction over Pleasantville Road to an intersection [at a point near the Fawn Township line;] with Burtner Road; thence in a [southerly] easterly direction over Burtner Road to a point on Route 70 [near the Natrona Road,] and the westerly terminus of Route 02160, in Harrison Township, Allegheny County, a distance of about 2.5 miles.

Section 2. This act shall take effect immediately.

AN ACT

SB 1187

Authorizing the Department of Property and Supplies, with the approval of the Secretary of Public Welfare and the Governor, to convey 5.608 acres, more or less, of land in Somerset Township, Somerset County, in exchange for a tract of land containing 1.086 acres, more or less, with the improvements thereon erected, also situate in Somerset Township, Somerset County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Secretary of Public Welfare and the Governor, is hereby authorized to convey in the name of the Commonwealth of

Pennsylvania to the Pennsylvania Turnpike Commission, its successors and assigns, a parcel of land situate in the Township of Somerset, County of Somerset, Commonwealth of Pennsylvania, bounded and described as follows:

Beginning at a point in the northern right-of-way line of the Pennsylvania Turnpike, said point being opposite turnpike center line station 747+01.56, 100 feet distant measured therefrom at right angles; thence along the turnpike northern right-of-way line north 27 degrees, 17 minutes, 39 seconds west 261.12 feet to a point; thence continuing along the same north 66 degrees, 57 minutes, 30 seconds west 550.90 feet to a point on the eastern edge of a road; thence along the eastern edge of the road north 22 degrees, 11 minutes, 00 seconds west 226.70 feet to a point; thence south 73 degrees, 36 minutes, 00 seconds east 980.10 feet to a point; thence south 11 degrees, 33 minutes, 30 seconds west 448.68 feet to a point in the northern right-of-way line of the Pennsylvania Turnpike; thence along said right-of-way line north 66 degrees, 57 minutes, 30 seconds east, 150.00 feet to the point and place of beginning, containing 5.608 acres more or less of land.

Being part of the lands formerly of the Somerset County Poor District which became vested in the Commonwealth of Pennsylvania, Department of Public Welfare, by the act of September 29, 1938, (P. L. 53).

Section 2. The deed of conveyance shall be approved by the Department of Justice and shall be executed by the Secretary of Property and Supplies in the name of the Commonwealth of Pennsylvania.

Section 3. The conveyance shall be made in exchange for a grant and conveyance to the Commonwealth of Pennsylvania, and its assigns, by the Pennsylvania Turnpike Commission, of a tract of land, hereinafter described, with the old Somerset County Home thereon erected, and the Department of Property and Supplies is hereby authorized and empowered to accept on behalf of the Commonwealth of Pennsylvania, by deed from the Pennsylvania Turnpike Commission, the tract of land situate in the Township of Somerset, County of Somerset, Commonwealth of Pennsylvania, bounded and described as follows:

Beginning at an iron pin at the intersection of the western line of a fourteen feet wide concrete drive and the northern line of U. S. Route 219; thence along the northern line of U. S. 219 north 82 degrees, 59 minutes west 266.10 feet to an iron pin at the intersection of the eastern line of a nine feet wide concrete drive and the northern line of U. S. Route 219 aforesaid; thence by land of Somerset State Hospital north 6 degrees, 34 minutes east 174.70 feet to an iron pin at the intersection of the eastern line of said concrete drive and the southern line of a fourteen feet wide concrete drive; thence continuing along land of Somerset State Hospital south 64 degrees, 08

minutes east 266.90 feet to an iron pin at the intersection of the southern line of the concrete drive with the western line of another fourteen feet wide concrete drive; thence continuing along land of the Somerset State Hospital south 6 degrees, 48 minutes west 180.60 feet to an iron pin, the point and place of beginning, containing 1.086 acres more or less of land.

Being the residue of land owned by the Commissioners of Somerset County, Pennsylvania, as successors in office to the Directors of the Poor of said county, when title to the remainder thereof, became vested in the Commonwealth of Pennsylvania, Department of Public Welfare, by the act of September 29, 1938 (P. L. 53).

Section 4. The land to be conveyed to the Pennsylvania Turnpike Commission is necessary to the enlargement and improvement of the North Somerset Service Station of the Pennsylvania Turnpike and the land to be conveyed to the Commonwealth of Pennsylvania, with the building thereon erected, is located within the area of the Somerset State Hospital.

Section 5. This act shall take effect immediately.

AN ACT

HB 1080

To provide for an additional law judge of the court of common pleas in the seventh judicial district.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. In addition to the judges provided for in the act of January 8, 1952 (P. L. 1844), entitled "An act to designate the several judicial districts of the Commonwealth, as required by the Constitution, and to provide for the election and commissioning of judges learned in the law for the said districts," an additional law judge is hereby authorized and provided for the court of common pleas of the seventh judicial district, who shall possess the same qualifications which are required by the Constitution and laws for the president judge of the court of common pleas of the district and who shall hold his office for a like term and by the same tenure and shall have the same power, authority and jurisdiction and shall be subject to the same duties, re-
