dollars (\$5) a month; in boroughs whose population is more than seven hundred fifty and not more] less than fifteen hundred, a maximum of [ten dollars (\$10)] twenty-five dollars (\$25) a month; in boroughs whose population is [more than fifteen hundred and not more than twenty-five hundred, a maximum of fifteen dollars (\$15) a month; in boroughs whose population is more than twenty-five hundred and not more than five thousand, a maximum of twenty dollars (\$20) a month; in boroughs whose population is more than five thousand and not more than ten thousand, a maximum of fifty dollars (\$50) a month; and] fifteen hundred or more but less than three thousand a maximum of thirty dollars (\$30) a month; in boroughs whose population is three thousand or more but less than five thousand, a maximum of fifty dollars (\$50) a month; in boroughs whose population is five thousand or more but less than ten thousand, a maximum of one hundred dollars (\$100) a month; in boroughs whose population is [more than] ten thousand [, a maximum of one hundred dollars (\$100)] or more but less than fifteen thousand, a maximum of one hundred fifty dollars (\$150) a month; and in boroughs whose population is fifteen thousand or more, a maximum of two hundred dollars (\$200) a month.

The population shall be determined by the latest available official census figures. In no case shall the compensation herein provided for any councilman exceed that of the mayor in any given borough.

Section 2. This act shall take effect immediately.

The General Assembly of the Commonwealth of Pennsylvania

Amending the act of June 3, 1937 (P. L. 1225), entitled "An act concerning game and other wild birds and wild animals; and amending, revising, consolidating, and changing the law relating thereto," further regulating shooting near highways and providing a penalty.

hereby enacts as follows:

Section 1. Section 807, act of June 3, 1937 (P. L. 1225), known as "The Game Law" amended October 2, 1959 (P. L. 1007), is amended to read:

Section 807. Shooting at Wild Birds or Wild Animals While on Highways.—It is unlawful for any person to shoot at any wild bird or wild animal while it is on a public highway, or a highway open to use or used by the public, or knowingly to shoot across a public highway, or a highway open to use or used by the public, while hunting, unless the line of fire is high enough above the elevation of the highway to preclude any danger to the users thereof; <u>or, for any person, after</u>

alighting from a motor vehicle being driven on, or stopped on or along a public highway, or road open to public travel, to shoot at any wild bird or wild animal while the person doing the shooting is within twenty-five yards of the traveled portion of a highway or road open to public travel.

Any person violating any of the provisions of this section shall, upon conviction, be sentenced to pay a fine of twenty-five dollars (\$25) and costs of prosecution.
