Amending the act of August 8, 1961 (P. L. 971), entitled "An act to regulate the sale and distribution for agricultural purposes of ground limestone, burned and hydrated lime, gypsum, slag, and related products in the Commonwealth of Pennsylvania; conferring powers and imposing duties on the Department of Agriculture; establishing fees; making an appropriation and prescribing penalties," providing further for the disposition of revenues.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (b) of section 5, act of August 8, 1961 (P. L. 971), known as the "Pennsylvania Agricultural Lime Act," is amended to read:

Section 5. Control Fee.—* * *

(b) Sales of agricultural liming materials to manufacturers or exchanges between them are hereby exempted from the control fee. Registration and control fees and fines, when collected, shall be [placed in the Feed and Fertilizer Fund to be used solely] <u>paid into</u> the State Treasury, and shall be credited to the general government operations appropriation of the Department of Agriculture for the payment of the costs of inspection, sampling, analysis, and other expenses necessary for the administration of this act and other acts specified by the General Assembly [and as much thereof as is necessary is hereby appropriated from time to time].

Section 2. This act shall take effect immediately.

HB 1763

Amending the act of June 5, 1957 (P. L. 248), entitled "An act relating to the distribution, sale or transportation of deficient or misbranded insecticides, fungicides, rodenticides and other pesticides; regulating traffic therein; providing for registration and examination of such materials; and imposing penalties," increasing the registration fees and providing for the disposition of revenues.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (b) of section 5, act of June 5, 1957 (P. L. 248), known as the "Pennsylvania Pesticide Act of 1957," is amended to read:

Section 5. Registration.—* * *

(b) Each pesticide shall be registered with the secretary before being offered for sale, sold or otherwise distributed in this Commonwealth. The application for registration shall be submitted to the secretary on forms which he shall supply, and shall be accompanied by a fee of [seven dollars and fifty cents (\$7.50) per brand, for the first ten brands registered and two dollars (\$2) per brand for each brand registered in excess thereof] ten dollars (\$10) per brand. Upon approval by the secretary, a copy of the registration shall be furnished to the applicant. All registrations shall expire on the thirty-first day of December of each year. The registration fees and fines, when collected, shall be [placed in the Feed and Fertilizer Fund to be administered by the secretary] paid into the State Treasury and shall be credited to the general government operations appropriation of the Department of Agriculture for the payment of the costs of inspection, sampling, analysis and other expenses necessary for the
