other than a device, certificate or other paper expressly allowed, or directed by the secretary to be displayed: Provided, however, That signal lamps of a type approved by the secretary shall not be considered a violation of this section.

- (b) Every permanent windshield on a motor vehicle shall be equipped with a device for cleaning rain, snow or other moisture, from the windshield, which device shall be so constructed as to be controlled or operated by the operator of the vehicle.
- (c) On and after July 1, 1968 every new motor vehicle with a permanent windshield registered in the Commonwealth shall be equipped with a device for washing the windshield which device shall be so constructed as to be controlled or operated by the operator of the vehicle.

Penalty.—Any person violating any of the provisions of this section, shall, upon summary conviction before a magistrate, be sentenced to pay a fine of five dollars (\$5.00) and costs of prosecution, and, in default of the payment thereof, shall undergo imprisonment for not more than three (3) days.

Amending the act of April 17, 1893 (P. L. 21), entitled, as amended, "An act to facilitate the labors of the judges of the court of common pleas and orphans' court of the county in which the seat of government is or may be located, in the disposition of the business of the Commonwealth, by providing suitable clerical assistance," providing for an administrative assistant to such courts.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 1, act of April 17, 1893 (P. L. 21), entitled, as amended, "An act to facilitate the labors of the judges of the court of common pleas and orphans' court of the county in which the seat of government is or may be located, in the disposition of the business of the Commonwealth, by providing suitable clerical assistance," amended August 14, 1963 (P. L. 1062), is amended to read:

Section 1. Be it enacted, &c., That to facilitate the labors of the judges of the court of common pleas and orphans' court of the county

in which the seat of government is or may be located in the disposition of the business of the Commonwealth, the said judges are hereby authorized to appoint and set the salaries of stenographers and clerks provided the cost of such help shall not exceed the sum of seven thousand two hundred fifty-eight dollars (\$7258) per annum for each of said judges, and a like sum of seven thousand two hundred fifty-

eight dollars (\$7258) for an administrative assistant to such courts.

Such salaries shall be paid by the Commonwealth. Section 2. This act shall take effect immediately.

HB 551

Amending the act of June 24, 1939 (P. L. 872), entitled "An act to consolidate, amend and revise the penal laws of the Commonwealth," excluding the sale of antiques from prohibitions against Sunday sales.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 699.10, act of June 24, 1939 (P. L. 872), known as "The Penal Code," amended July 19, 1967 (Act No. 51), is amended to read:

Section 699.10. Selling Certain Personal Property on Sunday.—Whoever engages on Sunday in the business of selling, or sells or offers for sale, on such day, at retail, clothing and wearing apparel, clothing accessories, furniture, housewares, home, business or office furnishings, household, business or office appliances, hardware, tools, paints, building and lumber supply materials, jewelry, silverware, watches, clocks, luggage, musical instruments and recordings, or toys, excluding novelties, [and] souvenirs and antiques, shall, upon convic-

tion thereof in a summary proceeding for the first offense, be sentenced to pay a fine of not exceeding one hundred dollars (\$100), and for the second or any subsequent offense committed within one year after conviction for the first offense, be sentenced to pay a fine of not exceeding two hundred dollars (\$200) or undergo imprisonment not exceeding thirty days in default thereof. No individual who by reason of his religious conviction observes a day other than Sunday as his day of rest and actually refrains from labor or secular business on that day shall be prohibited from selling the above enumerated
