Amending the act of May 6, 1968 (Act No. 61), entitled "An act providing for grants to be made by the Commonwealth for the construction, rehabilitation, alteration, expansion, or improvement of certain site development facilities; imposing duties and powers on the Secretary of Commerce and the Department of Commerce; and making an appropriation," providing for grants to be made by the Commonwealth for assistance in the acquisition of land located in designated impoverished urban areas

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The title and clause (7) of section 2, act of May 6, 1968 (Act No. 61), known as the "Site Development Act," are amended to read:

Providing for grants to be made by the Commonwealth for the construction, rehabilitation, alteration, expansion, or improvement of certain site development facilities and assistance in the acquisition

of land located in designated impoverished urban areas; imposing

duties and powers on the Secretary of Commerce and the Department of Commerce; and making an appropriation.

Section 2. Definitions.—As used in this act:

(7) "Project costs" include the cost of design and engineering, together with such other expenses as may be necessary or incident to the construction of the site development project and the placing of the same in operation, and, in the case of a site development project under clause (5) of section 3 of this act, the cost of acquisition.

Section 2. Section 3 of the act is amended by adding at the end thereof, a new clause to read:

Section 3. Grants for Site Development Projects.—The secretary is hereby authorized, upon application of any eligible municipality, municipal authority, industrial development agency, or State agency, to make grants to said municipality, municipal authority, industrial development agency, or State agency for the construction, rehabilitation, alteration, expansion, or improvement of the following site development projects:

* * *

(5) The acquisition of land and existing improvements located in impoverished urban areas as certified by the Secretary of ¹ Public

Welfare.

Section 3. Section 4 of the act is amended to read:

Section 4. Grant Limitations.—The amount of any project grant made under the authority of section 3 of this act shall not exceed fifty percent of project costs; and, in no case shall the amount of any project grant be in excess of ten percent of the appropriation under this act, nor shall the total amount of such grants to cover the acquisition of land and existing improvements under clause (5) of section 3 of this act exceed twenty-five percent of the appropriation under this act.

Section 4. The sum of one million dollars (\$1,000,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Commerce for the purposes set forth in the "Site Development Act."

Section 5. This act shall take effect July 1, 1968.

Amending the act of March 10, 1949 (P. L. 30), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," providing minimum salaries and increments for professional and temporary professional employes.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 930, act of March 10, 1949 (P. L. 30), known as the "Public School Code of 1949," is amended by adding at the end thereof a new subsection to read:

Section 930. Professional and Temporary Professional Employes.—* * *

(j) Minimum Salaries and Increments. All professional and temporary professional employes of county boards of school directors shall be entitled to the same minimum salaries and increments within their respective class as professional and temporary professional em-
