Section 304.5. Damages.—Nothing contained in the aforesaid sections 304.1, 304.2, 304.3 or 304.4 shall be considered as enlarging or changing the formulas employed in determining just compensation under the provisions of the "Eminent Domain Code." The damages herein provided are in lieu of the damages provided for in sections 608, 609 and 610 of the "Eminent Domain Code."

Section 304.6. Administration of Relocation Assistance Program.

—The Secretary of Highways may make relocation payments or provide relocation assistance or otherwise carry out the functions required under this act by utilizing the facilities, personnel, and services or any other Federal, State or local governmental agency having an established organization for conducting relocation assistance programs.

Section 304.7. Supervision by Secretary of Highways; Rules and Regulations.—The secretary shall have the power and it shall be his duty to exercise general supervision over the administration and enforcement of the provisions of this act and he shall adopt rules and regulations to implement them.

Section 2. The provisions and benefits of this act shall take effect immediately upon approval and shall apply to all amicable acquisitions and condemnations effected thereafter and shall also apply to all amicable acquisitions effected after August 23, 1968, and all condemnations filed after August 23, 1968, the effective date of the Federal-aid Highway Act of 1968 (Chapter 5, Title 23 U. S. C.), which this act implements.

HB 238

Amending the act of June 1, 1959 (P. L. 392), entitled "An act relating to the retirement of State employes; amending, revising, consolidating and chang-

ing the laws relating thereto," extending credit for military service to certain State employes who were State employes prior to serving in the armed forces of the United States.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Subsection (5) of section 207, act of June 1, 1959 (P. L. 392), known as the "State Employes' Retirement Code of 1959," added December 1, 1965 (P. L. 1025), is amended to read: Section 207. Credit for Military Service.—

(5) Any State employe who is a contributor and who served in the armed forces of the United States subsequent to September 16, 1940, [and who was not a State employe prior to such period of military service] and who commenced or returned to State employment within three (3) years from date of release from active duty, shall be entitled to have full credit for each year or fraction thereof not to exceed five (5) years of the service in the armed forces of the United States upon his payment to the fund of back contributions according to the provisions of article III, section 302 subsection (2).

Authorizing the Department of Property and Supplies, with the approval of the Governor, to sell and convey 1.421 acres with appurtenances situate in McConnellsburg Borough, Fulton County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The Department of Property and Supplies, with the approval of the Governor, is hereby authorized on behalf of the Department of Highways and the Commonwealth of Pennsylvania, to sell and convey to the Borough of McConnellsburg, Fulton County for a consideration of one dollar (\$1), the following described tract of land situate in McConnellsburg Borough, Fulton County and Commonwealth of Pennsylvania.

Beginning at an iron pin, the corner of McConnellsburg Borough and Ayr Township line; thence by said line south 73 degrees, 59
