SB 1696

Making an appropriation to the Department of Military Affairs from restricted revenue in the Motor License Fund for the use of the Pennsylvania Aeronautics Commission.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one million five hundred sixty-four thousand two hundred fifty-five dollars (\$1,564,255), or as much thereof as may be necessary, is hereby specifically appropriated from the restricted revenue account for aviation fuel taxes in the Motor License Fund to the Department of Military Affairs for the fiscal year July 1, 1968 to June 30, 1969, for the proper conduct of the work of the Pennsylvania Aeronautics Commission, including payment of expenses of the commission and salaries, wages or other compensation of an executive director and other employes; for the payment of general expenses, supplies, printing, and equipment; for the development and maintenance of State airports, and the maintenance and repair of landing fields, intermediate landing fields, landing field equipment, beacon sites, other navigation facilities, and the encouragement and development of civil aeronautics.

Section 2. In addition to this amount, all moneys received from the operations at the State airports, including but not limited to rentals, concessions, and landing fees, shall be paid into the Motor License Fund and credited to this appropriation.

Section 3. This act shall take effect July 1, 1968.

SB 1697

Making an appropriation to the Department of Military Affairs from restricted revenue in the Motor License Fund to be used by the Pennsylvania Aeronautics Commission for the encouragement and development of aeronautics.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of three million sixty-seven thousand one hundred thirty-eight dollars (\$3,067,138), or as much thereof as may be necessary, is hereby specifically appropriated from the restricted revenue account for aviation fuel taxes in the Motor License Fund to the Department of Military Affairs for the fiscal period July 1, 1968 to June 30, 1969, to be used by the Pennsylvania Aeronautics, Commission for the encouragement and development of aeronautics, for the development and maintenance of State airports, for assistance to political subdivisions and municipal authorities of the Commonwealth in the construction and improvement of airports and other aeronautical facilities, including the making of surveys and plans and the necessary construction work and equipment: Provided, how-

ever, That no more shall be expended from this item for such purposes or any of them than may be required to match an equal sum contributed by any political subdivision or municipal authority of the Commonwealth or by the Federal government, or by a political subdivision or municipal authority and the Federal government as provided in the act of May 2, 1947 (P. L. 136).

Section 2. This act shall take effect July 1, 1968.

A SUPPLEMENT

SB 1637

To the act of April 1, 1863 (P. L. 213), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making an appropriation for carrying the same into effect, providing for a tuition supplement to all full-time Pennsylvania resident students, providing a method of accounting for the funds appropriated, and requiring reports to the members of the General Assembly.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. In order to carry into effect the act of Congress, approved July 2, 1862, granting public land to the several states for educational purposes, and subsequent acts of Congress related thereto, and the act of the General Assembly of Pennsylvania accepting the provisions and conditions of said acts of Congress and pledging the faith of the State to carry the same into effect, the sum of fifty-nine million two hundred twenty-two thousand two hundred forty-one dollars (\$59,222,241), or as much thereof as may be necessary, is hereby specifically appropriated to the trustees of the Pennsylvania State University for the fiscal year July 1, 1968 to June 30, 1969, for the following purposes and in the amounts as shown:

(1) For the general maintenance of instruction, research, and extension in the College of Agriculture, the College of Arts and Architecture, the College of Business Administration, the College of Engineering, the College of the Liberal Arts, the College of Human Development, the College of Earth and Mineral Sciences, the College of Science, the College of Education, the Graduate School, the College of Health and Physical Education, the Commonwealth Campuses, the Continuing Education Services and for the general maintenance of other schools, departments, offices and services, including repairs and improvements to the grounds and buildings, service of light, heat, power, water and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest and such other expenditures as the trustees may deem necessary and practicable; but the total sum of such expenditures shall not exceed fifty-one million three hundred forty-six thousand four hundred fortyone dollars (\$51,346,441).

(2) For the purpose of carrying on research and investigation to discover by-products of anthracite and bituminous coal and uses therefor, of developing new scientific, chemical, industrial, domestic and other uses and new and extended markets for anthracite coal and its products and for employing engineers, chemists, technical experts, assistants, clerks, stenographers, and other employes and purchasing such machinery, supplies, equipment, apparatus, and other things necessary in the furtherance of the aforesaid research and investigation, to be used by the College of Earth and Mineral Sciences under the supervision of the State Department of Mines and Mineral Industries. Moneys shall be expended for this purpose only to the extent that a sum equal to fifty per cent of thirty-seven thousand eight hundred dollars (\$37,800), the amount to be expended by the Commonwealth, is contributed to the Pennsylvania State University by the members of the anthracite and bituminous coal industry. Affidavits evidencing such contributions shall be submitted by the university to the Auditor General.

(3) For the purpose of carrying on research and investigation of long-range problems affecting the mineral industries. No more shall be expended for this purpose than may be required to match an equal sum contributed to the university by one or more industries for such research and investigation. The total contribution by the Commonwealth shall not exceed thirty-one thousand fifty dollars (\$31,050). Affidavits evidencing such contribution shall be submitted by the university to the Auditor General.

(4) The support of research and investigation of basic problems affecting the slate and other nonmetallic mineral industries, eighteen thousand nine hundred dollars (\$18,900).

(5) For research in the diseases of maple trees, ten thousand dollars (\$10,000).

(6) For the support of research and investigation of long-range basic problems affecting the mineral industries, seventeen thousand five hundred fifty dollars (\$17,550).

(7) For the use of the College of Agriculture for expenditures by the Agricultural Experiment Station for the support of research and investigation directed toward the development and production of superior strains of crops and livestock and to develop more efficient methods of producing and marketing such products, eighty-one thousand dollars (\$81,000).

(8) For the maintenance and the support of research and experimental investigation or problems relating to the petroleum industry of the State, seventy thousand dollars (\$70,000).

(9) For the use of the College of Agriculture for expenditure by the Agricultural Experiment Station for research in the communicable diseases of mushrooms, marketing, engineering and other phases of the mushroom industry, ninety-seven thousand five hundred dollars (\$97,500).

(10) For the use of the College of Agriculture for expenditures by the Agricultural Experiment Station for research and investigation of mastitis in the dairy cattle, twenty-seven thousand dollars (\$27,000).

(11) For a tuition supplement the sum of four million one hundred eighty-five thousand dollars (\$4,185,000), or as much thereof as may be necessary. The moneys so appropriated by this clause shall be applied by the Pennsylvania State University solely for the purpose of maintaining for full-time Pennsylvania resident students in all schools and colleges of the university, a tuition and fee rate of one hundred fifty dollars (\$150) per term at University Park and one hundred thirty dollars (\$130) per term at the Commonwealth Campuses, and for maintaining fees for part-time students who are residents of Pennsylvania at sixteen dollars (\$16) per credit for all students at University Park Campus, fourteen dollars (\$14) per credit for all students at Commonwealth Campuses and Continuing Education Credit Centers and twelve dollars (\$12) per unit for certificate students. The tuition supplement shall be applied to the tuition and fees for Pennsylvania resident students as follows: for full-time Pennsylvania resident students at University Park the tuition and fee rate of one hundred seventy-five dollars (\$175) per term shall be reduced by the amount of twenty-five dollars (\$25) per term, for full-time Pennsylvania resident students at the Commonwealth Campuses the tuition rate of one hundred seventy-five dollars (\$175) per term shall be reduced by the amount of forty-five dollars (\$45) per term, for part-time Pennsylvania resident students the credit hour rate of twenty-two dollars (\$22) per credit shall be reduced by the amount of six dollars (\$6) for those at University Park Campus, and shall be reduced by the amount of eight dollars (\$8) for those at Commonwealth Campuses and Continuing Education Credit Centers, and the rate of fifteen dollars (\$15) per unit for certificate students shall be reduced by three dollars (\$3) for students who are residents of Pennsylvania. The funds appropriated under this clause may be used by the Pennsylvania State University for the same purposes as tuition and fees received from students. The Board of Trustees may increase tuition and fees as necessary in the event that the amounts appropriated are not sufficient to maintain the university. Any dollar increase in tuition and fees for Pennsylvania resident students must be accompanied by an equal or greater dollar increase for nonresident students.

(12) For payment of the employer's share of social security costs, three million three hundred thousand dollars (\$3,300,000), or as much thereof as may be necessary. Amounts not required for the employer's share of social security shall be lapsed to the General Fund.

Section 2. The Pennsylvania State University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates. the Pennsylvania State University shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the money appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the Pennsylvania State University to the Treasurer of the Commonwealth. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right of review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require. As to the moneys appropriated for the purposes specified in section 1, clause (11), the Auditor General shall determine that the required number of full-time Pennsylvania resident students have been charged the specified tuition and the bona fides of the residence of those claiming to be Pennsylvania residents.

Section 3. The colleges carrying out the research projects hereby authorized shall submit a complete report on each project to each member of the General Assembly of the Commonwealth of Pennsylvania by June 30, 1969.

Section 4. This act shall take effect July 1, 1968.

A SUPPLEMENT

SB 1638

To the act of July 28, 1966 (Act No. 3, Third Special Session), entitled "An act providing for the establishment and operation of the University of Pittsburgh as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; authorizing appropriations in amounts to be fixed annually by the General

Assembly; providing for the auditing of accounts of expenditures from said appropriations; providing for public support and capital improvements; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the chancellor to make an annual report of the operations of the University of Pittsburgh," making appropriations to the Trustees of the University of Pittsburgh for the general maintenance and operation of the university, for the School of Medicine, for the Library School, for staffing programs in nursing, for the Jonas E. Salk Professorship, the Allegheny Observatory, and the Computing Center, for a tuition supplement to all Pennsylvania resident students of the university; and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of thirty-two million three thousand one hundred thirty-two dollars (\$32,003,132), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the University of Pittsburgh for the fiscal year July 1, 1968 to June 30, 1969, for the following purposes and in the amounts as shown:

(1) For the general maintenance of all schools, departments, divisions, offices, and services of the university, with the exception of the School of Medicine, the Library School, the Allegheny Observatory, and the Computing Center; including repairs and improvements to the grounds and buildings, service of light, heat, power, water and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest, and such other expenditures as the trustees may deem necessary and practicable; but the total sum of such expenditures shall not exceed nine million seven hundred eighty-one thousand three hundred seventy-eight dollars (\$9,781,378).

(2) For a tuition supplement the sum of eighteen million seven hundred sixty-two thousand eight hundred forty dollars (\$18,762,-840), or as much thereof as may be necessary. The moneys so appropriated by this clause shall be applied by the University of Pittsburgh solely for the purpose of maintaining for full-time and parttime Pennsylvania resident students in all schools and divisions of the university, a uniform tuition and fee rate of two hundred seventyfive dollars (\$275) per trimester for full-time Pennsylvania resident students and establishing an undergraduate credit-hour rate of seventeen dollars (\$17) and a graduate and professional credit-hour rate of twenty dollars (\$20) for part-time Pennsylvania resident students at all campuses. The tuition supplement shall be applied to the tuition and fees for Pennsylvania resident students at all campuses as follows: For full-time Pennsylvania resident undergraduate students the tuition and fee rate of seven hundred fifty dollars (\$750) per trimester shall be reduced by four hundred seventy-five dollars (\$475) per trimester, for full-time Pennsylvania resident graduate or professional students in the Schools of Medicine, Dentistry and Public Health the tuition and fee rate of eight hundred dollars (\$800) per trimester shall be reduced by five hundred twenty-five dollars (\$525) per trimester, for full-time Pennsylvania resident graduate or pro-

fessional students in the Schools of Law, Business, Social Work and all other post-baccalaureate programs the tuition and fee rate of seven hundred fifty dollars (\$750) per trimester shall be reduced by four hundred seventy-five dollars (\$475) per trimester, for parttime Pennsylvania resident undergraduate students at all campuses the credit hour rate of fifty dollars (\$50) per credit shall be reduced by thirty-three dollars (\$33), for part-time Pennsylvania resident graduate or professional students in the Schools of Medicine, Dentistry, and Public Health the credit hour rate of sixty-seven dollars (\$67) shall be reduced by forty-seven dollars (\$47) per credit, for part-time Pennsylvania resident graduate or professional students in the Schools of Law, Business, Social Work and all other postbaccalaureate programs the credit hour rate of sixty-two dollars (\$62) shall be reduced by forty-two dollars (\$42) per credit. The funds appropriated under this clause may be used by the University of Pittsburgh for the same purposes as tuition and fees received from students.

(3) For the general maintenance of the School of Medicine, including repairs and improvements to the grounds and buildings, service of light, heat, power, water and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest, and such other expenditures as the trustees may deem necessary and practicable, but the total sum of such expenditures shall not exceed two million twenty-six thousand eight hundred fifty dollars (\$2,026,850).

(4) For the general maintenance of the Library School, including repairs and improvements to the grounds and buildings, service of light, heat, power, water and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest, and such other expenditures as the trustees may deem necessary and practicable, but the total sum of such expenditures shall not exceed two hundred thirty thousand five hundred ninetyeight dollars (\$230,598).

(5) For the staffing of a baccalaureate and graduate professional program in nursing, the sum of two hundred eighty-nine thousand five hundred fifty dollars (\$289,550).

(6) For a Professorship in Experimental Medicine in the School of Medicine of the University to be known as the Commonwealth Jonas E. Salk Professorship of Experimental Medicine to be filled with that member of the medical profession who, in the opinion of the Trustees of the University of Pittsburgh, has made an outstanding contribution in the field of experimental medicine, the sum of thirty-four thousand dollars (\$34,000).

(7) For the general maintenance of the Allegheny Observatory, including repairs and improvements to the grounds and buildings, service of light, heat, power, water, and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest, and such other expenditures as the trustees may deem necessary and practicable, but the total sum of such expenditures shall not exceed ninety-two thousand six hundred fifty-six dollars (\$92,656).

(8) For the general maintenance of the Computing Center, including repairs and improvements to the grounds and buildings, service of light, heat, power, water, and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest, and such other expenditures as the trustees may deem necessary and practicable, but the total sum of such expenditures shall not exceed seven hundred eighty-five thousand two hundred sixty dollars (\$785,260).

Section 2. The University of Pittsburgh shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, the University of Pittsburgh shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the University of Pittsburgh to the Treasurer of the Commonwealth. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require. As to the moneys appropriated for the purposes specified in section 1, clause (2), the Auditor General shall determine that the required number of Pennsylvania residents have been charged the specified tuition rate, and the bona fides of the residence of those claiming to be Pennsylvania residents.

ditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University," making appro-priations for carrying the same into effect, providing for a tuition supple-ment to all full-time and part-time Pennsylvania resident students, and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of thirty-three million four hundred forty thousand five hundred sixty-seven dollars (\$33,440,567), or as much thereof as may be necessary, is hereby specifically appropriated to the trustees of Temple University at Philadelphia for the fiscal year of July 1, 1968 to June 30, 1969, for the following purposes and in the amounts as shown:

(1) For the general maintenance of all schools, departments, divisions, offices, and services of the university, with the exception of the School of Medicine, including repairs and improvements to the grounds and buildings, service of light, heat, power, water, and sewage disposal, salaries and wages, materials, supplies, equipment books and periodicals, insurance and interest, and such other expenditures as may be necessary and practicable, but the total sum of such expenditures shall not exceed twenty million eight thousand five hundred seventy-four dollars (\$20,008,574).

(2) For a tuition supplement the sum of nine million five hundred ninety-eight thousand three hundred fifty-one dollars (\$9,598,351), or as much thereof as may be necessary. The moneys so appropriated by this clause shall be applied by Temple University ¹ solely for the purpose of maintaining for full-time Pennsylvania resident students in all schools and divisions of the university ² a uniform tuition and fee rate of four hundred fifty dollars (\$450), and establishing an undergraduate credit-hour rate of fourteen dollars (\$14) and a graduate credit-hour rate of sixteen dollars (\$16) for part-time Pennsylvania resident students, and for the purpose of establishing at the Ambler Campus and at all other extension ³ campuses or centers of the university a uniform tuition and fee rate of three hundred ninety dollars (\$390) for full-time Pennsylvania resident 'students. The tuition supplement shall be applied to the tuition and fees for Pennsylvania resident students as follows: For full-time Pennsylvania resident undergraduate and graduate students at the main campus the tuition and fee rate of four hundred sixty dollars (\$460) per semester shall be reduced by two hundred thirty-five dollars (\$235) per semester, for full-time Pennsylvania resident students in the School of Medicine the tuition and fee rate of six hundred thirtyfour dollars (\$634) per semester shall be reduced by four hundred

nine dollars (\$409) per semester, for full-time Pennsylvania resident undergraduate students at the Ambler Campus the tuition and fee rate of four hundred sixty dollars (\$460) per semester shall be reduced by two hundred sixty-five dollars (\$265) per semester, for part-time Pennsylvania resident undergraduate students at the main campus the credit-hour rate of twenty-eight dollars (\$28) per credit hour shall be reduced by fourteen dollars (\$14) per credit, for parttime Pennsylvania resident graduate students at the main campus the credit-hour rate of thirty-two dollars (\$32) per credit shall be reduced by sixteen dollars (\$16) per credit. The funds appropriated under this clause may be used by Temple University for the same purpose as tuition and fees received from students. The Board of Trustees may increase tuition and fees as necessary in the event that the amounts 1 appropriated are not sufficient to maintain the uni-Any dollar increase in tuition and fees for Pennsvlvania versity. resident students must be accompanied by an equal or greater dollar increase for nonresident students.

(3) For the general maintenance of the School of Medicine, including repairs and improvements to the grounds and buildings, service of light, heat, power, water, and sewage disposal, salaries and wages, materials, supplies, equipment, books and periodicals, insurance and interest and such other expenditures as may be necessary and practicable, but the total sum of such expenditures shall not exceed three million eight hundred thirty-three thousand six hundred forty-two dollars (\$3,833,642).

Temple University shall apply the moneys appropriated Section 2. by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates. Temple University shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Temple University to the Treasurer of the Commonwealth. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require. As to the moneys appropriated for the purposes specified in section 1, clause (2), the Auditor General shall determine that the required number of full-time Pennsylvania resident students have been charged the specified tuition rate, that the ratio of resident

The sum of two hundred seven thousand two hundred dollars (\$207,200), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Forests and Waters for capital improvement projects for the Water Resources program, including various types of general improvements, alterations and construction.

Section 3. The sum of two hundred twenty-seven thousand three hundred dollars (\$227,300), or as much thereof as may be necessary, is hereby specifically appropriated to the Department of Forests and Waters for capital improvement projects for the Forest Services and Protection program, including various types of general improvements, alterations and construction at State forests.
