Making appropriations to the Pennsylvania Higher Education Assistance Agency to provide scholarships and educational assistance grants, to provide funds for lender participation incentives, to provide funds for the purpose of assisting approved institutions of higher learning in securing Federal funds for financial aid to students, and to administer the agency and otherwise carry out the provisions of the act of August 7, 1963 (P. The following sums are hereby specifically appropriated to the Pennsylvania Higher Education Assistance Agency for the fiscal year July 1, 1969 to June 30, 1970 to be transferred to and deposited in the Higher Education Assistance Fund as requested by the agency, for the following uses and purposes:

For payment of scholarships and educational assistance grants under the provisions of the act of January 25, 1966 (P. L. 1546) ......\$51,410,876

For the purpose of administering the programs of the agency authorized under the act of August 7, 1963 (P. L. 549) and the act of January 25, 1966 (P. L. 1546), including payment of lender participation incentives...... \$ 1,589,124

Provided, however. That in addition hereto, the agency may use no more than five hundred thousand dollars (\$500,000) from its accrued and future earnings from funds invested by the Board of Directors for administration of the guaranty loan program during the 1969-1970 fiscal year under the act of August 7, 1963 (P. L. 549).

(3) For the purpose of assisting approved institutions of higher learning in securing and obtaining maximum participation in Federal student aid funds to be used as financial aid to students in meeting their costs of attendance at such institutions under the provisions of the act of January

Section 2. Payments to Pennsylvania State University on account of the appropriation for resident education, as provided in clause (1) of section 1 of this act, shall be made on the basis of the number of credit hours or equivalent credit hours produced during the fiscal year.

Section 3. Payments to Pennsylvania State University on account of the appropriations for continuing education, extension services, organized research and special departmental research as provided in clauses (2), (3), (4) and (5) of section 1 of this act, shall be made on the basis of the net costs of such programs. The net cost of each such program shall be the excess of the expenditures made over the income received.

Section 4. Payments to Pennsylvania State University of the appropriations herein provided shall be made quarterly during the fiscal year as follows:

- (1) First payment on September 30, 1969;
- (2) Second payment on December 31, 1969;
- (3) Third payment on March 31, 1970; and
- (4) Final payment on June 30, 1970.

Such quarterly payments shall be made in accordance with the provisions of sections 2 and 3 of this act, on the basis of estimates of such credit hours or equivalent credit hours and net costs as submitted by Pennsylvania State University to the General Assembly and to the Auditor General not later than thirty days prior to the date on which such payment is to be made.

Section 5. The Pennsylvania State University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, the Pennsylvania State University shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year and the actual credit hours or equivalent credit hours and net costs, as provided in sections 2 and 3 of this act, used as a basis for receipt of any appropriation during said fiscal year. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the money appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the Pennsylvania State University to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of such actual credit hours or equivalent credit hours and net costs and make certification as to their correctness and the amounts of final payments due based thereon. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right of review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 6. This act shall take effect immediately.

The sum of thirty-seven million eight hundred ninety-nine thousand dollars (\$37,899,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the University of Pittsburgh for the fiscal year July 1, 1969 to June 30, 1970, for the following purposes and in the amounts as shown:

Section 2. Payments to the University of Pittsburgh on account of the appropriation for resident education, as provided in clause (1) of section 1 of this act, shall be made on the basis of the number of credit hours produced during the fiscal year except payments for medical programs which shall be made on the basis of full-time enrollment. Section 4. Payments to the University of Pittsburgh of the appropriations herein provided shall be made quarterly during the fiscal year as follows:

- (1) First payment on September 30, 1969;
- (2) Second payment on December 31, 1969;
- (3) Third payment on March 31, 1970; and
- (4) Fourth payment on June 30, 1970.

Such quarterly payments shall be made in accordance with the provisions of sections 2 and 3 of this act, on the basis of estimates of such credit hours, full-time equivalent students enrolled in medical programs and net costs as submitted by the University of Pittsburgh to the General Assembly and to the Auditor General not later than thirty days prior to the date on which such payment is to be made.

The University of Pittsburgh shall apply the moneys Section 5. appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, the University of Pittsburgh shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year and the actual credit hours, full-time equivalent students enrolled in medical programs and net costs. as provided in sections 2 and 3 of this act, used as a basis for receipt of any appropriation during said fiscal year. Such statement of expenditures, credit hours, full-time equivalent students enrolled in medical programs and net costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the University of Pittsburgh to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of such actual credit hours, full-time equivalent students enrolled in medical programs and net costs and make a certification as to their correctness and the amounts of final payments due based thereon. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

Section 6. This act shall take effect immediately.

Such research shall include (1) an experimental community geriatric clinic for the multidisciplinary evaluation of the aging individual in health and disease with emphasis on preventive health maintenance, early diagnosis of disease, assessment of total performance, capacity fitness for work and retirement, which will be available for all patients who may benefit from the service within the capacity of this clinic, (2) a research ward with beds devoted to controlled nutritional balance studies for specific projects related to chronic diseases of the older individual such as osteoporosis, cardiovascular, aging, connective tissue disorders and disturbances in the skeletal-muscular system, (3) studies on the physiology of aging with particular reference to the development of criteria and practical tests for the assessment of functional capacity and biological aging, and (4) basic biological research with particular reference to such aspects as genetic factors in aging, the role of physical activity in age changes and longitudinal studies covering the entire life span and cellular changes accompanying the aging process.
- (b) To implement the provisions of this act the hospital may establish a center for aging research and may for that purpose use the moneys hereby appropriated.

The appropriation made by this act is made on the condition that every mental defective admitted to the Elwyn Institute, after the effective date of this act, and who is a ward of the Commonwealth (i) shall be selected by the Department of Public Welfare from a list submitted from time to time to the department by the board of directors of the institution, and (ii) shall have been previously investigated by the Department of Revenue for the purpose of determining the extent, if any, such mental defective, or those legally liable for his or her support, may be financially able to pay the cost of the maintenance of the person in the institute.

Section 3. This act shall take effect July 1, 1970.

Section 2. Payments to the University of Pittsburgh of the appropriations herein provided shall be made during the fiscal year as follows:

- (1) First payment on September 30, 1970; and
- (2) Second payment on December 31, 1970.

The University of Pittsburgh shall apply the moneys Section 3. appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, the University of Pittsburgh shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth. and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the University of Pittsburgh to the Treasurer of the Commonwealth. Section 3. Temple University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, Temple University shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Temple University to the Treasurer of the Commonwealth. The sum of two million three hundred thousand dollars (\$2,300,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the Pennsylvania State University for the fiscal period July 1, 1970 to January 1, 1971, for the State's share of retirement costs.

Section 3. Payments to Pennsylvania State University of the appropriations herein provided shall be made during the fiscal year as follows:

- (1) First payment on September 30, 1970; and
- (2) Second payment on December 31, 1970.

Section 4. The Pennsylvania State University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, the Pennsylvania State University shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the money appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the Pennsylvania

State University to the Treasurer of the Commonwealth. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right of review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 5. This act shall take effect July 1, 1970.

The sum of one billion three hundred million dollars Section 1. (\$1,300,000,000), or as much thereof as may be necessary, is hereby specifically appropriated to the State Treasurer of the Commonwealth of Pennsylvania for the purpose of paying the salaries and wages of the officers and employes and other expenses of the State government in the interim between June 30, 1970 and March 1, 1971, or such time as moneys appropriated by the General Appropriation Act and other appropriation acts of 1970-1971 may become available for such purposes; and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1970. The funds provided by this act may be used for all preferred appropriations of 1969-70 but shall not be used for payment of public assistance, for payment of expenses and grants under the Pennsylvania Higher Education Assistance Agency, or for payment of appropriations to charitable or educational institutions not under the absolute control of the Commonwealth.

Section 2. In addition to the amount appropriated by this act, all moneys received from the Federal Government or from any other source as contributions to or payments for the programs provided herein shall be paid into the General Fund and are hereby appropriated out of the General Fund to the appropriation for the purposes and programs intended.

Section 3. Payments out of the appropriation of this act shall be made by the State Treasurer upon requisitions by the several departments, boards, commissions or officers in the same manner as payments ordinarily are made.

Section 4. All amounts paid by the State Treasurer in accordance with this act shall be charged against the appropriations made for salaries and wages of the officers and employes and other expenses of the State government in the General Appropriation Act and other appropriation acts of 1970-1971, except for those expenses in appropriations specifically excluded in section 1.

Section 5. This act shall take effect July 1, 1970.

Section 2. The amounts paid for all categories of public assistance shall continue to be paid at the one hundred per cent level of adequacy.
