Amending the act of September 18, 1961 (P.L.1389), entitled "An act establishing and taking over as State highways certain county highways, or sections thereof, tunnels, bridges, viaducts and approaches thereto, in counties, and certain streets and bridges in cities of the first class and in cities of the second class, and certain streets in cities of the second class A and third class, and certain township roads and certain streets in boroughs and incorporated towns; authorizing under certain terms and conditions their construction, maintenance, repair, reconstruction and improvement by the Commonwealth; conferring certain powers upon Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and deleting certain State highways," adding a new road and new bridges in Allegheny County.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 101 of Article I., act of September 18, 1961 (P.L.1389), entitled "An act establishing and taking over as State highways certain county highways, or sections thereof, tunnels, bridges, viaducts and approaches thereto, in counties, and certain streets and bridges in cities of the first class and in cities of the second class, and certain streets in cities of the second class A and third class, and certain township roads and certain streets in boroughs and incorporated towns; authorizing under certain terms and conditions their construction, maintenance, repair, reconstruction and improvement by the Commonwealth; conferring certain powers upon Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and deleting certain State highways," is amended by adding a category to read:

ARTICLE I. COUNTIES.

Section 101. All or part of the following various public highways, or sections thereof, bridges, tunnels, viaducts and approaches thereto, in counties, shall, if and when the county commissioners consent thereto by resolution a copy of which shall be filed in the office of the clerk of the courts of the proper county and with the Department of Highways, be adopted by the Commonwealth as a State highway, and shall thereafter be maintained, repaired and constructed in the same manner with like power and authority as provided by the laws of the Commonwealth applicable to State highways; however, no highway bridge, viaduct or approach thereto shall be taken over by the Commonwealth under the provisions of this act if a contract for the improvement thereof has been entered into between a contractor and the Commonwealth or local

authorities, or both, until such contract shall have been completed.

Allegheny County

Streets Run Road, southwardly from State Highway Route 02-229 at the City of Pittsburgh - Borough of Baldwin line through the Borough of Baldwin, the Borough of West Mifflin and the Borough of Baldwin to State Highway Route 330 (Traffic Route 51), thence continuing to its intersection with Brownsville Road in the Borough of Whitehall, a distance of approximately 3.6 miles, including the following bridges:

Bridge No. 6 Streets Run

Bridge No. 7 Streets Run

Bridge No. 8 Streets Run

Bridge No. 9 Streets Run

Bridge No. 10 Streets Run

Bridge No. 11 Streets Run

Section 2. Section 102 of the act is amended by adding a subsection to read:

Section 102. * * *

(d) The highway and bridges in Category IV., established as a State highway under the provisions of this act, may be taken over for construction and maintenance at any time subsequent to the final enactment of this act, and shall be taken over not later than January 1, 1972.

Section 3. This act shall take effect immediately.
