### A SUPPLEMENT

### SB 574

To the act of November 30, 1965 (P.L.843), entitled "An act providing for the establishment and operation of Temple University as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in tuition; providing for public support and capital improvements; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University," making an appropriation to meet the university deficit for the 1970-71 fiscal year.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of twenty million six hundred ninety-six thousand dollars (\$20,696,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of Temple University at Philadelphia to meet a university deficit caused by the failure to make the full appropriation in the fiscal year 1970-71 because of insufficient revenues, for the following purposes: Resident Education; Extension Services; Organized Research; Special Departmental Research and Computer Center.

Section 2. Payments to Temple University of the appropriations herein provided shall be made during the fiscal year as follows:

- (1) First payment on September 30, 1971
- (2) Second payment on December 31, 1971

Temple University shall apply the moneys appropriated by Section 3. this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than April 30, 1972, Temple University shall file with the General Assembly and with the Auditor General of the Commonwealth a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during the fiscal period for which this appropriation is made. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Temple University to the Treasurer of the Commonwealth. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right

to review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 4. This act shall take effect July 1, 1971.

SB 575

To the act of July 28, 1966 (P.L.87), entitled "An act providing for the establishment and operation of the University of Pittsburgh as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; providing for public support and capital improvements; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the chancellor to make an annual report of the operations of the University of Pittsburgh," making an appropriation to meet the university deficit for the 1970-71 fiscal year.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of eighteen million nine hundred fifty thousand dollars (\$18,950,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the University of Pittsburgh to meet the university deficit caused by the failure to make the full appropriation in the fiscal year 1970-71 because of insufficient revenues, for the following purposes: Resident Education; Continuing Education; Computer Center and University Press.

Section 2. Payments to the University of Pittsburgh of the appropriations herein provided shall be made during the fiscal year as follows:

(1) First payment on September 30, 1971, and

(2) Second payment on December 31, 1971.

Section 3. The University of Pittsburgh shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such money. Not later than April 30, 1972, the University of Pittsburgh shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during the fiscal period for which this appropriation is made. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the University of Pittsburgh to the Treasurer of the Commonwealth. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General

shall have the right to review only and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

Section 4. This act shall take effect July 1, 1971.

## A SUPPLEMENT

SB 576

To the act of April 1, 1863 (P.L.213), entitled "An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of Agricultural Colleges," making appropriations to the Trustees of the Pennsylvania State University to meet certain deficits for the 1970-71 fiscal year.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. In order to carry into effect the act of Congress, approved July 2, 1862, granting public land to the several states for educational purposes, and subsequent acts of Congress related thereto, and the act of the General Assembly of Pennsylvania accepting the provisions and conditions of said acts of Congress and pledging the faith of the State to carry the same into effect, the sum of thirty-two million two hundred eighty-one thousand dollars (\$32,281,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the Pennsylvania State University to meet the university deficit caused by the failure to make the full appropriation in the fiscal year 1970-71 because of insufficient revenues, for the following purposes: Resident Education; Continuing Education; Extension Services; Organized Research and Special Departmental Research.

Section 2. The sum of two million three hundred thousand dollars (\$2,300,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the Pennsylvania State University to meet the State's share of retirement costs deficit caused by the failure to make the full appropriation in the fiscal year 1970-71 because of insufficient revenues, for the State's share of retirement costs.

Section 3. Payments to the Pennsylvania State University of the appropriations herein provided shall be made during the 1971-72 fiscal year as follows:

First payment on September 30, 1971

Second payment on December 31, 1971

Section 4. The Pennsylvania State University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than April 30, 1972, the Pennsylvania State University shall file with the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during the fiscal period for which these appropriations are made. Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth and he shall have the right in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the Pennsylvania State University to the Treasurer of the Commonwealth. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right of review only, and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 5. This act shall take effect July 1, 1971.

Such statement of expenditures shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the money appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the Pennsylvania State University to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of such actual credit hours or equivalent credit hours and net costs and make certification as to their correctness. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right of review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 6. The university shall file on or before March 1, 1972 with the appropriation committees of the General Assembly and with the Auditor General of the Commonwealth in such detail and form as prescribed by the respective appropriation committees of the General Assembly and the Auditor General:

Such statement of expenditures, credit hours and net costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the University of Pittsburgh to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of such actual credit hours and net costs and make a certification as to their correctness. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

Section 6. The university shall file on or before March 1, 1972 with the appropriation committees of the General Assembly and with the Auditor General of the Commonwealth in such detail and form as prescribed by the respective appropriation committees of the General Assembly and the Auditor General:

(1) A statement listing all research projects undertaken with State funds provided for from moneys appropriated by this act. Each designated research project shall be accounted for separately.

(2) Progress reports on all projects involving State funds appropriated under the provisions of this act.

(3) A listing of all contracts with the Commonwealth, and the status thereof, as part of their annual fiscal report.

Section 7. The university shall present its financial statements required under the provisions of this act in accordance with the generally accepted accounting principles for educational institutions as set forth in College and University Business Administration Revised Edition, 1968.

Section 8. This act shall take effect immediately.

The sum of eight million one hundred thousand dollars (\$8,100,000), or as much thereof as may be necessary, is hereby appropriated and allocated to the Office of the Governor, the State Treasurer and to Motor License Fund administrative departments, boards and commissions and other agencies which are part of the executive branch of the State Government for the purpose of providing funds for a cost-of-living salary or wage increase for the fiscal year 1971-1972 for State employes in such offices, departments, boards, commissions and other agencies.

Section 2. The Governor shall provide a plan and make allocations from this appropriation to the various offices, departments or agencies for the 1971-1972 fiscal year in such amounts as may be necessary to provide funds for a cost-of-living salary or wage increase for State employes in such offices, departments or agencies; and subject to the further provision that none of the allocations hereunder shall be made in violation of Presidential Executive Order 11615, and any subsequent rules and regulations thereto.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 2, act of August 31, 1971 (Act No. 27-A), known as "The General Appropriation Act of 1971," is amended by adding an item under the Milk Marketing Board, amending the first item and adding an item thereafter under the Department of Property and Supplies, adding an item after the second item under the Department of State and amending the thirty-second item under the Senate to read:

Section 2. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated from the General Fund to the several hereinafter named agencies of the Executive, Legislative and Judicial Departments of the Commonwealth for the payment of the salaries, wages or other compensation and travel expense of the duly elected or appointed officers and employes of the Commonwealth, for payment of fees of contractual services rendered, for the purchase or rental of goods, services, printing, equipment, land and buildings and for payment of any other expenses, as provided by law or by this act, necessary for the proper conduct of the duties, functions and activities and for the purposes hereinafter set forth for the fiscal year beginning July 1, 1971, and for the payment of bills incurred and remaining unpaid at the close of the fiscal period ending June 30, 1971.

The term "expenses" and "maintenance" shall include all printing, binding and stationery, food and forage, materials and supplies, traveling expenses, training, motor vehicle supplies and repairs, freight, express, and cartage, postage, telephones and telegraph rentals and toll charges, newspaper advertising and notices, fuel, light, heat, power and water, repairs or reconstruction of equipment, buildings and facilities, rent of real estate and equipment, premiums on workmen's compensation, insurance premiums on policies of liability insurance, premiums on medical payment insurance and surety bonds for volunteer workers, premiums on employe group life insurance, and employe and retired employe group hospital and medical insurance, payment of Commonwealth share of social security taxes for State employes, the purchase of replacement or additional equipment and machinery and all other incidental costs and expenses, including payment to the Department of Property and Supplies of mileage and other charges for the use of automobiles and rental payments for permanently assigned automobiles and of expenses or costs of services incurred through the Purchasing Fund. The term "expenses" also shall include the medical costs for the treatment of inmates of State institutions when the inmate must be transferred to an outside hospital: Provided, That in no case shall the State institution pay more for patient care than that provided under the State medical assistance program.

Section 2. Payment from said appropriation shall be made by requisition of the Department of Justice of the Commonwealth of Pennsylvania upon proof of such claims to the satisfaction of the Department of Justice and the Auditor General.

Section 3. This act shall take effect immediately.
