## AN ACT

HB 1808

Authorizing the Department of Public Welfare, with the approval of the Secretary of Public Welfare, the Secretary of Agriculture and the Governor to transfer certain real property in Susquehanna Township, Dauphin County, from the Department of Public Welfare to the Department of Agriculture.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The jurisdiction and control of all those tracts or parcels of land situate in Susquehanna Township, Dauphin County, described as follows, are hereby transferred from the Department of Public Welfare to the Department of Agriculture:

## Parcel 1.

Beginning at a point in the centre of Hospital Road 25 feet south of the north side of Maclay Street at property of the Pennsylvania State Lunatic Hospital; thence northwardly along the property of the said Pennsylvania State Lunatic Hospital 150 feet; thence westwardly along the property of said hospital 200 feet to the Pennsylvania Canal; thence northwardly along the said canal 670 feet to property now or late of Robert's estate; thence eastwardly by said property 100 feet to the centre of Paxton Creek; thence down through the centre of said Paxton Creek by its several courses to the centre of Hospital Road 25 feet south of the north side of Maclay Street and thence westwardly through the centre of said Hospital Road 205 feet to the place of beginning containing 4.07 acres.

## Parcel 2.

Beginning at a stake on Maclay Street, the "division" line between the city of Harrisburg and Susquehanna Township aforesaid, where said street intersects the Pennsylvania Canal on the eastern side of said canal; thence along the line of the property of the said Pennsylvania Canal Company, northerly a distance of 150 feet to a stake; thence on a line parallel with said Maclay Street easterly, a distance of 200 feet to a stake; thence on a line parallel with the first mentioned line, coming along the line of the property of the said Pennsylvania Canal Company, southerly a distance of 150 feet, to a stake on Maclay Street; thence westerly along the line of said Maclay Street, a distance of 200 feet, to a stake the place of beginning.

Section 2. The transfer shall become effective when instruments are drawn, executed and acknowledged by the Secretary of Public Welfare and the Secretary of Agriculture, with the approval of the Governor, and in the manner approved by the Department of Justice. The instrument or instruments effecting the transfer shall be duly recorded in the county where the transferred area is located. Section 3. This act shall take effect immediately.
