## AN ACT

## HB 1188

Amending the act of August 21, 1953 (P.L.1306, No. 370),) entitled, as amended, "An act prescribing the fees to be received by the clerks of orphans' courts of counties of the fifth, sixth, seventh and eighth class," establishing a fee and increasing others.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:
