The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of one million eight hundred eighty-seven thousand dollars (\$1,887,000), or as much thereof as may be necessary, is hereby specifically appropriated to the Trustees of the College of Lincoln University, Chester County, for the fiscal year July 1, 1973 to June 30, 1974, for net costs of instruction.

Section 2. Payments to Lincoln University on account of the appropriation for the items provided in section 1 of this act shall be made on the basis of net costs during the fiscal year.

Section 3. Payments to Lincoln University of the appropriation herein provided shall be made monthly during the fiscal year.

Such monthly payments shall be made in accordance with the provisions of sections 1 and 2 of this act, on the basis of estimated net costs. The estimate of net costs shall be submitted by Lincoln University to the Secretary of Education, the General Assembly and to the State Treasurer not later than thirty days prior to the date on which such payment is to be made.

Section 4. Lincoln University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, Lincoln University shall file with the Secretary of Education, the General Assembly and with the Auditor General of the Commonwealth a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and net costs, as provided in section 2 of this act, used as a basis for receipt of any appropriation during said fiscal year. Such statement of expenditures and net costs shall be reviewed by the Auditor General of the Commonwealth,

and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Lincoln University to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of net costs and make certification as to their correctness. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

- Section 5. The university shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in "College and University Business Administration" of the American Council on Education, Revised Edition, 1968, without exception.
- Section 6. A report shall be submitted to the Governor and the appropriations and education committees of the Senate and House of Representatives and shall include data for all programs of the university. The report, to be submitted prior to November 1, 1974, shall cover the twelve-month period beginning September 1, 1973. The report shall include for each term during the period:
  - (1) The following counts and distributions:
- (i) The definitions and numbers of full-time faculty members, of part-time faculty members, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses, and of part-time students enrolled in undergraduate courses;
- (ii) A distribution of part-time faculty members by the percentage of full-time employment;
- (iii) Total numbers of undergraduate student credits and of graduate student credits;
- (iv) Number of different courses scheduled, distributed by the number of sections scheduled in each course and the sections distributed by the number of students enrolled in each section;
  - (v) Number of terms scheduled and the dates thereof.
- (2) A classification of faculty members or other professional employees by title including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian, and academic administrator; faculty members or other professional employees under each title to be subdivided by type of assignment: undergraduate courses only, graduate courses only, or both graduate and undergraduate courses; and each such set of faculty members or other professional employees to be further subdivided by type of employment: full-time or part-time; and the following aggregates for each such subdivided classification:

- (i) The number;
- (ii) The sum of credits assigned to undergraduate courses taught;
- (iii) The sum of credits assigned to graduate courses taught;
- (iv) The sum of undergraduate student credits and the sum of graduate student credits generated;
- (v) Total salary paid;
- (vi) Total salary paid from Federal funds;
- (vii) Total salary paid from university funds.
- (3) For each term of the period covered an analysis of the average hours per week spent in university-related activities for each full-time faculty member identified by school, department and title.
- Section 7. In addition to the requirements of section 6, the report covering the twelve-month period beginning September 1, 1973 shall include for all programs of the university:
- (1) Minimum number of credits required for a baccalaureate degree, and for a master's degree.
- (2) Number of bachelor's degrees, master's degrees, first professional degrees, and doctoral degrees awarded in 1971, 1972, 1973, and estimated 1974.

Section 8. This act shall take effect immediately.

The Governor shall provide a plan and make allocations from this appropriation to the various offices, departments or agencies for the 1973-1974 fiscal year in such amounts as may be necessary to provide funds for general salary or wage and benefits increases for State employes in such offices, departments or agencies.

Section 1. In order to carry into effect the act of Congress, approved July 2, 1862, granting public land to the several states for educational purposes, and subsequent acts of Congress related thereto, and the act of the General Assembly of Pennsylvania accepting the provisions and conditions of said acts of Congress and pledging the faith of the State to carry the same into effect, the following sums or as much thereof as may be necessary are hereby specifically appropriated to the Trustees of the Pennsylvania State University for the fiscal year July 1, 1973 to June 30, 1974, for the purposes and in the amounts as shown:

- (3) For net cost of extension and public services ........... 8,913,000

Section 2. Payments to Pennsylvania State University on account of the appropriations for all items as provided in section 1 of this act except for instruction - Doctor of Medicine shall be made on the basis of net costs during the fiscal year.

Payments for instruction - Doctor of Medicine shall be made on the basis of full-time equivalent students enrollment at the rate of seven thousand four hundred sixty-five dollars (\$7,465) per student.

Section 3. If necessary, the Pennsylvania State University may transfer funds among the appropriations listed in section 1, clauses (1), (2), (3) and (4): Provided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed five per cent of the amount specifically appropriated for that purpose.

Section 4. Payments to the Pennsylvania State University of the appropriations herein provided shall be made monthly during the fiscal year.

Such monthly payments shall be made in accordance with the provisions of sections 2 and 3 of this act, on the basis of estimated net costs and full-time equivalent students enrolled in the Doctor of Medicine

program. The estimate of net costs shall be submitted by the Pennsylvania State University to the Secretary of Education, the General Assembly and to the State Treasurer not later than thirty days prior to the date on which such payment is to be made.

Section 5. The Pennsylvania State University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, the Pennsylvania State University shall file with the Secretary of Education, the General Assembly, and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year, the number of full-time equivalent students enrolled in the Doctor of Medicine program and net costs, as provided in sections 2 and 3 of this act, used as a basis for receipt of any appropriation during said fiscal year.

Such statement of expenditures and number of full-time equivalent students enrolled in the Doctor of Medicine program and net costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the Pennsylvania State University to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of full-time equivalent students enrolled in the Doctor of Medicine program and net costs and make a certification as to their correctness. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

- Section 6. Two reports shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs of the university except the Doctor of Medicine program. The first report, to be submitted prior to December 1, 1973, shall cover the period from June 25, 1973 to August 18, 1973. The second report, to be submitted prior to November 1, 1974, shall cover the twelve-month period beginning September 1, 1973. Each report shall include for each term during the period:
  - (1) The following counts and distributions:
- (i) The definitions and numbers of full-time faculty members, of part-time faculty members, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses, and of part-time students enrolled in undergraduate courses;
- (ii) A distribution of part-time faculty members by the percentage of full-time employment;

- (iii) Total numbers of undergraduate student credits and of graduate student credits:
- (iv) Number of different courses scheduled, distributed by the number of sections scheduled in each course and the sections distributed by the number of students enrolled in each section;

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated to the Trustees of the University of Pittsburgh for the fiscal year July 1, 1973 to June 30, 1974, for the purpose and in the amounts as shown:

- (1) For net cost of instruction excluding Doctor of Medicine .......\$41,093,000 (2) For net cost of student aid .......\$2,960.000
- Section 2. Payments to the University of Pittsburgh on account of the appropriations for all items, as provided in section 1 of this act except for instruction Doctor of Medicine shall be made on the basis of net costs during the fiscal year.

Payments for instruction - Doctor of Medicine shall be made on the basis of full-time equivalent student enrollment at the rate of seven thousand four hundred sixty-five dollars (\$7,465) per student.

Section 3. If necessary the University of Pittsburgh may transfer funds between the appropriations listed in section 1, clauses (1) and (2): Provided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed five per cent (5%) of the amount specifically appropriated for that purpose.

Section 4. Payments to the University of Pittsburgh of the appropriations herein provided shall be made monthly during the fiscal year.

Such monthly payments shall be made in accordance with the provisions of section 2 of this act on the basis of estimated net costs and full-time equivalent students enrolled in the Doctor of Medicine program. The estimate of net costs shall be submitted by the University of

Pittsburgh to the Secretary of Education, the General Assembly and to the Treasurer of the Commonwealth not later than thirty days prior to the date on which such payment is to be made.

Section 5. The University of Pittsburgh shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, the University of Pittsburgh shall file with the Secretary of Education, the General Assembly and with the Auditor General of the Commonwealth, a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year, the number of full-time equivalent students enrolled in the Doctor of Medicine program and net costs, as provided in section 2 of this act, used as a basis for receipt of any appropriation during said fiscal year.

Such statement of expenditures, and number of full-time equivalent students enrolled in the Doctor of Medicine program and net costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by the University of Pittsburgh to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of full-time equivalent students enrolled in the Doctor of Medicine program and net costs and make a certification as to their correctness. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning such expenditures as the General Assembly or any of its committees may require.

Two reports shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs of the university except the Doctor of Medicine program. The first report, to be submitted prior to December 1, 1973, shall cover the period from April 25, 1973 to August 7, 1973. The second report, to be submitted prior to November 1, 1974, shall cover the twelve-month period beginning September 1, 1973. Each report shall include for each term during the period:

- (2) Number of bachelor's degrees, master's degrees, first professional degrees, and doctoral degrees awarded in 1971, 1972, 1973, and estimated 1974.
- Section 8. The university shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in "College and University Business Administration" of the American Council on Education, Revised Edition, 1968, without exception.

#### HB 1001

To the act of November 30, 1965 (P.L.843, No.355), entitled "An act providing for the establishment and operation of Temple University as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in tuition; providing for public support and capital improvements; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University," making appropriations for carrying the same into effect, providing for a basis for payments of such appropriations and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated to the Trustees of Temple University at Philadelphia for the fiscal year July 1, 1973 to June 30, 1974, for the purposes and in the amounts as shown:

- (1) For net cost of instruction excluding Doctor of Medicine ......\$44,255,000
- (3) For net cost of extension and public services ........... 53,000
- (4) For instruction Doctor of Medicine only ............... 5,255,360

Section 2. Payments to Temple University on account of the appropriations for all items, as provided in section 1 of this act, except for instruction - Doctor of Medicine, shall be made on the basis of net costs during the fiscal year.

Payments for instruction - Doctor of Medicine only shall be made on the basis of full-time equivalent students enrolled at the rate of seven thousand four hundred sixty-five dollars (\$7,465) per student.

Section 3. If necessary, Temple University may transfer funds among the appropriations listed in section 1, clauses (1), (2) and (3): Provided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed five per cent of the amount specifically appropriated for that purpose.

Section 4. Payment to Temple University of the appropriations herein provided shall be made monthly during the fiscal year.

Such monthly payments shall be made in accordance with the provisions of sections 2 and 3 of this act, on the basis of estimated net costs and full-time equivalent students enrolled in the Doctor of Medicine program. The estimate of net costs shall be submitted by Temple

University to the Secretary of Education, the General Assembly and to the State Treasurer not later than thirty days prior to the date on which such payment is to be made.

Temple University shall apply the moneys appropriated by this act only for such purposes as are permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than one hundred twenty days after the close of the fiscal year to which this act relates, Temple University shall file with the Secretary of Education, the General Assembly and with the Auditor General of the Commonwealth a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year the number of full-time equivalent students enrolled in the Doctor of Medicine program and net costs, as provided in section 2 of this act, used as a basis for receipt of any appropriation during said fiscal year. Such statement of expenditures, and number of full-time equivalent students enrolled in the Doctor of Medicine program and net costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes not permitted by this act and to cause such sums to be recovered and paid by Temple University to the Treasurer of the Commonwealth. The Auditor General shall also make a determination of full-time equivalent students enrolled in the Doctor of Medicine program and net costs and make certification as to their correctness. In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

Section 6. Two reports shall be submitted to the Governor and the Appropriations and Education Committees of the Senate and House of Representatives and shall include data for all programs of the university except the Doctor of Medicine program. The first report, to be submitted prior to December 1, 1973, shall cover the period from May 14, 1973 to August 17, 1973. The second report, to be submitted prior to November 1, 1974, shall cover the twelve-month period beginning September 1, 1973. Each report shall include for each term during the period:

- (1) The following counts and distributions:
- (i) The definitions and numbers of full-time faculty members, of part-time faculty members, of full-time students enrolled in graduate courses, of full-time students enrolled in undergraduate courses, of part-time students enrolled in graduate courses, and of part-time students enrolled in undergraduate courses;
- (ii) A distribution of part-time faculty members by the percentage of full-time employment;

- (iii) Total numbers of undergraduate student credits and of graduate student credits:
