Section 4. Section 2. Payments to Pennsylvania State University on account of the appropriations for all items as provided in section 1 of this act except for instruction - Doctor of Medicine shall be made on the basis of net costs during the fiscal year.

Payments for instruction - Doctor of Medicine shall be made on the basis of full-time equivalent students enrollment at the rate of seven thousand four hundred sixty-five dollars (\$7,465) per student.

Section 3. If necessary, the Pennsylvania State University may transfer funds among the appropriations listed in section 1, clauses (1), (2), (3) and (4): Provided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed five percent of the amount specifically appropriated for that purpose.

Section 4. Payments to the Pennsylvania State University of the appropriations herein provided shall be made monthly during the fiscal year.

To the act of November 30, 1965 (P.L.843, No.355), entitled "An act providing for the establishment and operation of Temple University as an instrumentality of the Commonwealth to serve as a State-related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in tuition; providing for public support and capital improvements; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to make an annual report of the operations of Temple University," making appropriations for carrying the same into effect, providing for a basis for payments of such appropriation and providing a method of accounting for the funds appropriated.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following sums, or as much thereof as may be necessary, are hereby specifically appropriated to the Trustees of Temple University at Philadelphia for the fiscal year July 1, 1974 to June 30, 1975, for the purposes and in the amounts as shown:

(1)	For net cost of instruction excluding Doctor of	
	Medicine	\$48,364,000
(2)	For net cost of student aid	3,018,000
(3)	For net cost of extension and public services	53,000

Section 2. Payments to Temple University on account of the appropriations for all items, as provided in section 1 of this act, except for instruction - Doctor of Medicine and for general institutional aid, shall be made on the basis of net costs during the fiscal year.

Payments for general institutional aid shall be made exclusively for reduction of the principal of that portion of debt incurred by Temple University prior to July 1, 1974, which (i) was not incurred in the establishment, conduct or maintenance of any program of instruction or any auxiliary enterprise, or (ii) was not secured by a bond or mortgage which pledges the revenues or property of Temple University as collateral: Provided, That such payments shall not be made until the Governor appoints a committee of not more than seven persons, four of whom shall be the chairman and the minority chairman of the Senate

Appropriations Committee and the chairman and the minority chairman of the House Appropriations Committee who will inquire into the management program and finances of the Temple University Hospital and its relationship to the university and make recommendations to the Governor and the General Assembly defining the role of Temple University Hospital in meeting the medical care needs of the community and eliminating its accumulated and continuing deficits. The university shall furnish to the committee such fiscal and program audits as the committee may request.

Section 3. If necessary, Temple University may transfer funds among the appropriations listed in section 1, clauses (1), (2) and (3): Provided, That the aggregate amount transferred into or out of each appropriation during the fiscal year shall not exceed five percent of the amount specifically appropriated for that purpose.

Not later than one hundred twenty days after the close of the fiscal year to which this act relates, Temple University shall file with the Secretary of Education, the General Assembly and with the Auditor General of the Commonwealth a statement setting forth the amounts and purposes of all expenditures made from moneys appropriated by this act and other university accounts during said fiscal year the number of full-time equivalent students enrolled in the Doctor of Medicine program and net costs, as provided in section 2 of this act, used as a basis for receipt of any appropriation during said fiscal year. Appropriating money made available under section 903 of the Federal Social Security Act to the Department of Labor and Industry for the administration of the Unemployment Compensation Law and public employment offices.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Pursuant to the provisions of section 602.3, act of December 5, 1936 (1937 P.L.2897, No.1), known as the "Unemployment Compensation Law," there is hereby appropriated out of funds made available to this Commonwealth under section 903 of the Federal Social Security Act, the sum of ten million seven hundred eight thousand six hundred thirty-nine dollars seventy-three cents (\$10,708,639.73), or so much thereof as may be necessary, to be used under the direction of the Bureau of Employment Security of the Department of Labor and Industry for the payment of expenses incurred for fiscal years 1974-75 and 1975-76 in the administration of the "Unemployment Compensation Law," and the public employment offices of the Commonwealth for which the Federal Government does not, in the opinion of the Department of Labor and Industry, provide sufficient funds.

These funds shall be used for the taking and processing of unemployment compensation claims, for the making of monetary and nonmonetary determinations, for the hearing and deciding of appeals, for the payment of salary increases, life and health insurance coverages, for travel expenses for bureau personnel provided for in union negotiated contracts, for the payment of unemployment compensation to separated bureau employes, for defraying the cost of employment services such as placement, counseling, testing, labor market information, service to veterans, the handicapped, minority groups, older workers, youth, women, and other related employment service functions.

Section 2. No part of the money hereby appropriated may be obligated after the expiration of the two-year period beginning on the date of enactment of this act.

Section 3. The amount obligated pursuant to this act during any twelve-month period beginning July first and ending on the next June thirtieth shall not exceed the amount by which the aggregate of the amounts credited to the account of this Commonwealth pursuant to section 903 of the Federal Social Security Act during such twelve-month period and the twenty-four preceding twelve-month periods exceeds the

aggregate of the amounts obligated for administration paid out for benefits and charged against the amounts credited to the account of this Commonwealth during such twenty-five twelve-month periods.

Section 4. This act shall take effect immediately.

To the act of July 5, 1973 (No.10-A), entitled "An act appropriating moneys in the Land and Water Development Fund derived from the issuance and sale of bonds and notes pursuant to the act of January 19, 1968 (P.L.996, No.443), known as 'The Land and Water Conservation and Reclamation Act'," providing an additional appropriation to the Department of Community Affairs.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of two million six hundred twenty-six thousand dollars (\$2,626,000), or as much thereof as may be necessary, is hereby appropriated to the Department of Community Affairs for two fiscal years beginning July 1, 1973 from moneys in the Land and Water Development Fund derived from the issuance and sale of bonds and notes pursuant to the act of January 19, 1968 (P.L.996, No.443), known as "The Land and Water Conservation and Reclamation Act," for the purposes specified in clause (4) of subsection (a) of section 16 of said act. said moneys being those previously appropriated to the Department of Community Affairs which have lapsed. Expenditures from this appropriation shall not be subject to the limitations set forth in subsection (c) of section 16 of said act. Any balance of this appropriation which remains unexpended, unencumbered or uncommitted after June 30, 1975, shall not lapse but shall remain to the credit of the Department of Community Affairs until expended in accordance with the provisions of this act.

Section 2. This act shall take effect immediately.
