AN ACT

SB 1288

Amending the act of June 22, 1931 (P.L.594, No.203), entitled "An act establishing certain township roads as State highways; authorizing their construction, maintenance and improvement under certain conditions and restrictions; limiting the obligation of the Commonwealth in the construction of certain structures located on such highways; conferring certain powers upon the Department of Highways and local authorities, persons, associations and corporations for sharing the cost of the maintenance and construction of such highways; and making an appropriation to carry out the provisions of said act," changing, adding and deleting routes in Whitehall Township, Lehigh County, including deletion of a portion of an undescribed application route.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following route in Lehigh County, act of June 22, 1931 (P.L.594, No.203), referred to as the Township State Highway Law is amended to read:

Route 39036. Beginning at a point at the intersection of Third Street and West Union Street, Fullerton; thence northerly through Whitehall Township to West Catasauqua in Whitehall Township to the intersection of **[Pine Street and First Avenue, PDH Station Marker 41-55,] Bridge Street**, then beginning again at the intersection of **[Pine Street and Main Street, PDH Station Marker 65-97] Schadt Avenue and Route 555 MacArthur Road; thence southwesterly on Schadt Avenue** to a point on Route 39038, about 0.6 of a mile southeast of Seiple, in Lehigh County, a distance of about **[2.13] 1.46** miles.

Section 2. The following route in Lehigh County is deleted to read:

[Route 39093. Beginning at a point on Lehigh Avenue at the western approach of the bridge crossing the Lehigh River from Catasauqua Borough to Whitehall Township, known as the Race Street Bridge; thence northwesterly on Lehigh Avenue to Main Street; thence westerly on Main Street crossing Route 39036 to an intersection with Route 39036 in Whitehall Township, Lehigh County, a distance of about 0.65 of a mile.]

Section 3. The following route in Lehigh County is added to read:

Route 39125. Beginning at a point at the intersection of First Avenue and Bridge Street; thence in a northeasterly direction over Bridge Street, to a point at the dividing line of Whitehall Township and the Borough of Catasauqua, on the Race Street Bridge, in Whitehall Township, Lehigh County, a distance of about 0.22 of a mile.

Section 4. The following portion of application route in Whitehall Township, Lehigh County, adopted in 1904 without a description, is deleted as follows: Beginning at a point on Main Street (Route 39050) at the intersection of Roosevelt Street; thence northwesterly on Roosevelt

Street to the intersection of Spruce Street, in Whitehall Township, Lehigh County, a distance of .21 mile.
