AN ACT

HB 1259

Amending the act of June 12, 1973 (P.L.56, No.24), entitled "A supplement to the act of October 11, 1972 (P.L.911, No.217), entitled 'An act providing for the capital budget for the fiscal year 1972-1973,' itemizing emergency life safety public improvement projects to be constructed by The General State Authority, together with their estimated financial costs," increasing two projects.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Clause A, and the total authorization and projects (12) and (27) of subdivision I of clause B of section 2, act of June 12, 1973 (P.L.56, No.24), known as the "Capital Budget Act for Fiscal Year 1972-1973, Public Improvement Project Itemization Supplement, Emergency Life Safety Code Improvements—The General State Authority," clause A and the total authorization of subdivision I of clause B of section 2, amended June 23, 1978 (P.L.518, No.83), are amended to read:

Section 2. Itemization and Authorization of Projects.—Additional capital projects in the category of public improvement projects to be constructed by The General State Authority, its successors or assigns, and to be financed by the incurring of debt, are hereby itemized, together with their respective estimated financial costs and the total additional amount authorized for public improvement projects, as follows:

Section 2. (a) The additional \$426,000 for the Clarks Summit State Hospital project includes \$221,369 previously allocated by administrative action. The \$204,631 balance shall be provided from excess funds available in the unallocated reserve of the Capital Facilities Fund.

(b) The additional \$542,000 for the Torrance State Hospital project includes \$391,271 previously allocated by administrative action. The \$150,729 balance shall be provided from excess funds available in the unallocated reserve of the Capital Facilities Fund.

Section 3. This act shall take effect immediately.
