SB 134

Establishing certain fees to be charged by clerks of the orphans' courts of counties of the fifth, sixth, seventh and eighth class and providing for fees in counties of the second, second A, third and fourth class.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The following fees shall be received by the clerks of orphans' courts of counties of the fifth, sixth, seventh and eighth class:

Section 2. In counties of the second, second A, third and fourth class all existing fees and charges collected by the Clerk of the Orphans' Court shall continue in effect and shall not be increased except by an act of the Legislature.

Section 3. The following acts or parts of acts are repealed insofar as they relate to fees collected by clerks of the orphans' courts in second through eighth class counties:

Section 1725 of Title 42, act of November 25, 1970 (P.L.707, No.230), known as the Pennsylvania Consolidated Statutes.

Section 24(a) of the act of July 9, 1976 (P.L.586, No.142), known as the "Judiciary Act of 1976."

Section 4. This act shall take effect in 60 days.
