Amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, adding judges of the courts of common pleas of the first, third, fourteenth, twenty-third, twenty-sixth, thirty-second, thirty-third, thirty-eighth, thirty-ninth, forty-second and forty-fifth judicial districts.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. Section 911(a) of Title 42 of the Pennsylvania Consolidated Statutes is amended to read:

- § 911. Courts of common pleas.
- (a) General rule.—There shall be one court of common pleas for each judicial district of this Commonwealth consisting of the following number of judges:

Section 2. The vacancies created by the new judgeships added by section 1 of this act shall be filled pursuant to 42 Pa.C.S. § 3135 (relating to increase in number of judges), except that the vacancies created in the fourteenth, twenty-third, thirty-second, thirty-third, thirty-eighth, forty-second and forty-fifth judicial districts shall be filled by election at the first municipal election occurring after the effective date of this act.

Section 3. This act shall apply to the twenty-sixth judicial district on January 1, 1989.

Section 4. This act shall take effect in 60 days.
