## A SUPPLEMENT

## HB 2556

To the act of July 9, 1990 (P.L.350, No.80), entitled "An act providing for the capital budget for the fiscal year 1990-1991," itemizing public improvement projects, furniture and equipment projects, transportation assistance projects, flood control projects and redevelopment assistance projects to be constructed or acquired or assisted by the Department of General Services, the Department of Transportation, the Department of Environmental Resources or the Department of Community Affairs, together with their estimated financial costs; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects to be constructed or acquired or assisted by the Department of General Services, the Department of Transportation, the Department of Environmental Resources or the Department of Community Affairs; stating the estimated useful life of the projects; making appropriations; and making repeals.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

**Section 1. Short title.**

This act shall be known and may be cited as the Capital Budget Project Itemization Act for 1990-1991.

**Section 2. Total authorizations.**

(a) **Public improvements.**—The total authorization for the additional capital projects in the category of public improvement projects itemized in section 3 and to be acquired or constructed by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, shall be \$1,178,183,000.

(b) **Furniture and equipment.**—The total authorization for the additional capital projects in the category of public improvement projects consisting of the acquisition of original movable furniture and equipment to complete public improvement projects itemized in section 4 and to be acquired or constructed by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, shall be \$47,487,100.

(c) **Transportation assistance.**—The total authorization for the capital projects in the category of transportation assistance projects itemized in section 5 with respect to which an interest is to be acquired in or constructed by the Department of Transportation, its successors or assigns, and to be financed by the incurring of debt, shall be \$279,009,000.

(d) **Flood control.**—The total authorization for the capital projects in the category of flood control projects itemized in section 6 and to be constructed by the Department of Environmental Resources, its successors or assigns, and to be financed by the incurring of debt, shall be \$137,555,000.

(e) **Redevelopment assistance.**—The total authorization for the additional capital projects in the category of redevelopment assistance projects

itemized in section 7 for capital grants by the Department of Community Affairs, its successors or assigns, and to be financed by the incurring of debt, shall be \$519,504,000.

**Section 3. Itemization of public improvement projects.**

Additional capital projects in the category of public improvement projects to be constructed or acquired by the Department of General Services, its successors or assigns, and to be financed by the incurring of debt, are hereby itemized, together with their respective estimated financial costs, as follows:

## Section 8. Funding of certain transportation projects.

(a) Limited waiver of local requirements.—The limitation on Department of Transportation funding of capital projects under the act of February 11, 1976 (P.L.14, No.10), known as the Pennsylvania Rural and Intercity Common Carrier Surface Transportation Assistance Act, pursuant to the policy of the department, shall be waived for Rural and Intercity Common Carrier Surface Transportation Assistance vehicle overhaul projects as set forth in section 5(b) of this act.

(b) Increase of limitation.—The limitation on Department of Transportation funding of capital projects under section 203(4) of the act of January 22, 1968 (P.L.42, No.8), known as the Pennsylvania Urban Mass Transportation Law, shall be increased to one-half of the net project costs for the Airport Busway Project and Extension of East Busway to the Tri-Boro Expressway contained in section 5(b)(18)(vi) and 5(b)(18)(vii), respectively, of this act.

## Section 9. Use of existing funds.

(a) Furniture and equipment.—Of the \$47,487,100 which is authorized for the purchase of original movable furniture and equipment for the projects which are included in section 4, the sum of \$7,424,000 shall be provided from excess funds available in the unallocated reserve of the Capital Facilities Fund from previous furniture and equipment appropriations.

(b) Public improvements.—Of the \$1,178,183,000 which is authorized for the acquisition or construction of public improvement projects under section 3, the sum of \$42,968,000 shall be provided from excess funds available in the unallocated reserve of the Capital Facilities Fund from previous public improvement appropriations.

## Section 10. Debt authorization.

(a) Public improvements.—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$1,135,215,000 as may be found necessary to carry out the acquisition and construction of the public improvement projects specifically itemized in a capital budget.

(b) Furniture and equipment.—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$40,063,100 as may be found necessary to carry out the public improvement projects consisting of the acquisition of original movable furniture and equipment specifically itemized in a capital budget.

(c) Transportation assistance.—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$279,009,000 as may be found necessary to carry out the acquisition and construction of the transportation assistance projects specifically itemized in a capital budget.

(d) Flood control.—The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$137,555,000 as may be found necessary to carry out the construction of the flood control projects specifically itemized in a capital budget.

(e) Redevelopment assistance.—Subject to the limitation in section 1616.1-B(b) of the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, the Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow, from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$519,504,000 as may be found necessary to carry out the redevelopment assistance projects specifically itemized in a capital budget.

#### Section 11. Issue of bonds.

The indebtedness authorized in this act shall be incurred, from time to time, and shall be evidenced by one or more series of general obligation bonds of the Commonwealth in such aggregate principal amount for each series as the Governor, Auditor General and State Treasurer shall determine, but the latest stated maturity date shall not exceed the estimated useful life of the projects being financed as stated in section 12.

#### Section 12. Estimated useful life and term of debt.

(a) Estimated useful life.—The General Assembly states that the estimated useful life of the public improvement projects itemized in this act is as follows:

- (1) Public improvement projects, redevelopment assistance projects and flood control projects, 30 years except for public improvement projects for modular units at State correctional institutions, 15 years.
- (2) Furniture and equipment projects, 10 years.
- (3) Transportation assistance projects:
  - (i) Rolling stock, 15 years.
  - (ii) Passenger buses, 12 years.
  - (iii) Furniture and equipment, 10 years.
  - (iv) All others, 30 years.

(b) Term of debt.—The maximum term of the debt authorized to be incurred under this act is 30 years.

**Section 13. Appropriations.**

(a) **Public improvements.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$1,135,215,000 to be used by it exclusively to defray the financial cost of the public improvement projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

(b) **Furniture and equipment.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$40,063,100 to be used by it exclusively to defray the financial cost of the public improvement projects consisting of the acquisition of original movable furniture and equipment specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

(c) **Transportation assistance.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Transportation in the maximum amount of \$279,009,000 to be used by it exclusively to defray the financial cost of the transportation assistance projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Transportation the moneys as required and certified by it to be legally due and payable.

(d) **Flood control.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Environmental Resources in the maximum amount of \$137,555,000 to be used by it exclusively to defray the financial cost of the flood control projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Environmental Resources the moneys as required and certified by it to be legally due and payable.

(e) **Redevelopment assistance.**—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Community Affairs in the maximum amount of \$519,504,000 to be used by it exclusively to defray the financial cost of the redevelopment assistance projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Community Affairs the moneys as required and certified by it to be legally due and payable.

**Section 14. Insurance proceeds.**

In addition to those funds appropriated in section 13, all moneys received from the Insurance Fund or from insurance carriers for fire damage to be repaired, restored or reconstructed for projects specifically itemized in this act are also hereby appropriated for those projects.

**Section 15. Federal funds.**

In addition to those funds appropriated in section 13, all moneys received from the Federal Government for the projects specifically itemized in this act are also hereby appropriated for those projects.

**Section 16. Delegation of public improvement projects.**

For the public improvement projects specifically itemized in section 3(13)(i)(A) and (B) of this act and section 3(13)(xxi)(C), (E), (G), (H), (J), (K) and (L) and (xxiv)(A) of the act of October 21, 1988 (P.L.851, No.113), known as the Capital Budget Project Itemization Act for 1987-1988, the Department of General Services may delegate the authority to construct, improve, equip, furnish, maintain, acquire or operate those projects to the Philadelphia Regional Port Authority.

**Section 17. Philadelphia Regional Port Authority restrictions.**

The public improvement projects itemized in section 3(13)(i)(A) and (B) shall be subject to the restrictions and conditions set forth in section 7(a) through (d) of the act of October 21, 1988 (P.L.851, No.113), known as the Capital Budget Project Itemization Act for 1987-1988.

**Section 18. Repeals.**

The following acts and parts of acts are repealed:

Section 1(B)(III)(3) of the act of December 30, 1974 (P.L.1105, No.356), entitled "A supplement to the act of February 6, 1974 (No.17), entitled 'An act providing for the capital budget for the fiscal year 1973-1974,' itemizing public improvement projects to be acquired or constructed by The General State Authority together with their estimated financial cost; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects stating the estimated useful life of the projects, and making an appropriation."

Section 2(5)(xxxiv) of the act of May 18, 1984 (P.L.263, No.62), entitled "A supplement to the act of December 20, 1983 (P.L.288, No.76), entitled 'An act providing for the capital budget for the fiscal year 1983-1984,' itemizing public improvement projects, furniture and equipment projects, redevelopment assistance projects and transportation assistance projects to be constructed or acquired or assisted by the Department of General Services, the Department of Transportation, the Department of Community Affairs or the Pennsylvania Fish Commission, together with their estimated financial cost; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects to be constructed or acquired or assisted by the Department of General Services, the Department of Transportation or the Department of Community Affairs; stating the estimated useful life of the projects; authorizing issuing officials to undertake limited temporary borrowing through negotiated settlements; and making an appropriation."

Sections 3(2)(v), (vi), (vii), (viii) and (x), (3)(viii)(A) and 4(2)(vi)(A) of the act of July 10, 1986 (P.L.1285, No.118), known as the Capital Budget Project Itemization Act for 1984-1985.

Section 3(5)(lxxx)(C), (cxxxvi)(P), (cxlvi)(E), (cl)(S) and (clvii)(B), (9)(x)(A) and (13)(xxi)(D) and (I) of the act of October 21, 1988 (P.L.851,

No.113), known as the Capital Budget Project Itemization Act for 1987-1988.

Section 5(b)(23)(xvii), (xviii), (xix), (xx), (xxi), (xxii), (xxiii), (xxiv) and (xxv) of the act of October 21, 1988 (P.L.851, No.113), known as the Capital Budget Project Itemization Act for 1987-1988, inasmuch as the project contained in section 5(b)(21)(xiv) of this act is a substitute for these projects.

Section 19. Editorial changes.

In editing and preparing this act for printing following the final enactment, the Legislative Reference Bureau shall insert or revise letters or numbers for projects where the letters or numbers are missing or require revision. The bureau shall also revise the total monetary amounts for the total authorization, debt authorization, appropriations and departmental totals as necessary to agree with the total monetary amounts of the projects.

Section 20. Effective date.

This act shall take effect immediately.

Section 13. Appropriations.

(a) Public improvements.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$1,135,215,000 to be used by it exclusively to defray the financial cost of the public improvement projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$297,447,000.

(b) Furniture and equipment.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of General Services in the maximum amount of \$40,063,100 to be used by it exclusively to defray the financial cost of the public improvement projects consisting of the acquisition of original movable furniture and equipment specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of General Services the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$35,190,100.

(c) Transportation assistance.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Transportation in the maximum amount of \$279,009,000 to be used by it exclusively to defray the financial cost of the transportation assistance projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Transportation the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$278,956,000.

(d) Flood control.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Environmental Resources in the maximum amount of \$137,555,000 to be used by it exclusively to defray the financial cost of the flood control projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Environmental Resources the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$62,551,000.

(e) Redevelopment assistance.—The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the Department of Community Affairs in the maximum amount of \$519,504,000 to be used by it exclusively to defray the financial cost of the redevelopment assistance projects specifically itemized in a capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay to the Department of Community Affairs the moneys as required and certified by it to be legally due and payable.

This item is approved in the sum of \$6,100,000.

I have withheld my approval from parts of the above appropriations because projects have been included in this bill which are not legal or are duplicates of projects approved in other capital budget acts or within House Bill 2556. In addition, a portion of the amounts have been reduced because the Commonwealth cannot afford a capital program to the extent proposed in House Bill 2556.

House Bill 2556, as passed by the General Assembly, contained a total of \$2,161,738,100 in projects in all categories. This amount is in addition to the over \$2.4 billion in projects authorized two years ago in Act 1988-113 and the over \$1.5 billion authorized four years ago in Act 1986-118. The financial resources of the Commonwealth will not support a capital program of this magnitude without substantial shifts in priorities for Commonwealth spending away from service programs to citizens in order to construct facilities, or a substantial increase in taxes.

The current backlog of capital projects already authorized is large. In order to maintain our bond rating and fiscal integrity, I have been limiting the amount of new construction and other capital projects which are undertaken each year. With this restraint, and the pressing need for new prisons which have already been authorized, it is not reasonable to raise expectations that many of the projects contained in House Bill 2556 will be undertaken in the near future. These projects will only add to the backlog of projects already existing.

I have decided to reduce the appropriations contained in this bill for much of the same reasons detailed in my signing message for 1988-113. The basic problems with that act are continued in this bill; projects are contained in the bill which do not meet the definitions of a capital project in the category of project where they are listed, and which the Commonwealth may not, therefore, legally fund under the Capital Facilities Debt Enabling Act; and the



scope of the capital program entailed in this bill is beyond the financial abilities of the Commonwealth to afford.

The following projects will not be implemented because they fall into one of the following areas:

- (1) The project does not meet the requirements of a capital project in the category in which it is listed.
- (2) The project is a duplicate of a project within House Bill 2556, or of a project which has been authorized in another capital budget act.
- (3) The project expands the scope of the current agency program.
- (4) The project is not included in an agency five-year capital budget plan. This criteria is being used in order to keep the backlog of projects within a reasonably affordable level. Projects not included within an agency's five-year capital plan are rarely implemented.
- (5) The project is a redevelopment assistance project for which a cap exists on the total amount of such projects which can be undertaken. Projects in excess of \$1 billion are currently authorized.
