Section 2. The sum of \$176,000 is hereby appropriated from the restricted revenue account within the Workmen's Compensation Administration Fund to the Office of Small Business Advocate in the Department of Community and Economic Development as provided in the act of June 2, 1915 (P.L.736, No.338), known as the Workers' Compensation Act, for the operation of the Office of Small Business Advocate.

Section 3. This act shall take effect July 1, 1999, or immediately, whichever is later.

(a) The sum of \$3,035,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Medicine, as authorized by section 907(a) of the act of October 15, 1975 (P.L.390, No.111), known as the Health Care Services Malpractice Act, for the operation of the board for the fiscal year July 1, 1999, to June 30, 2000.
- (b) The sum of \$494,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Osteopathic Medicine, as authorized by section 907(b) of the Health Care Services Malpractice Act, for the operation of the board for the fiscal year July 1, 1999, to June 30, 2000.
- (c) The sum of \$161,000, or as much thereof as may be necessary, is hereby appropriated from the restricted receipts account of the State Board of Podiatry, as authorized by section 907(c) of the Health Care Services Malpractice Act, for the operation of said board for the fiscal year July 1, 1999, to June 30, 2000.
- (d) The sum of \$317,000, or as much thereof as may be necessary, is hereby appropriated from the Athletic Commission Augmentation Account for the State Athletic Commission, as authorized by 5 Pa.C.S. § 1512 (relating to Athletic Commission Augmentation Account), for the support and operation of the commission for the fiscal year July 1, 1999, to June 30, 2000.
- (e) Each appropriation listed in subsections (a), (b), (c) and (d) shall not be treated as an augmentation to the Department of State, general government appropriation, or any other appropriation, but shall be treated and accounted for as separate appropriations respectively.

SB 737

Making an appropriation to the Philadelphia College of Osteopathic Medicine, Philadelphia.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

Section 1. The sum of \$5,222,000 is hereby appropriated to the Philadelphia College of Osteopathic Medicine, Philadelphia, for the fiscal year July 1, 1999, to June 30, 2000, for instruction in the Doctor of Osteopathy program.

Section 2. Payments to the Philadelphia College of Osteopathic Medicine on account of the appropriation provided in section 1 shall be made quarterly by the Secretary of Education on the basis of costs during the fiscal year and shall be conditioned on continuing authority for inclusion on the Board of Trustees of the Philadelphia College of Osteopathic Medicine of a minimum of five persons who are not elected officials and who are appointed by the Governor, the President pro tempore of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives and the Minority Leader of the House of Representatives for terms of office coterminous with that of the respective appointing authority.

Section 3. The Philadelphia College of Osteopathic Medicine shall provide full, complete and accurate information as may be required by the Department of Education or the chairman or the minority chairman of the Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House of Representatives.

Section 4. The Philadelphia College of Osteopathic Medicine shall report its revenues and expenditures and present its financial statements in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual (1975)" and the "Commonwealth of Pennsylvania Budget Instructions for the State System of Higher Education, State-Related Universities and Non-State-Related Colleges and Universities."

Section 5. The Trustees of the Philadelphia College of Osteopathic Medicine shall report on forms provided by the Department of Education to both the chairman and minority chairman of the Appropriations Committee of the Senate and the chairman and minority chairman of the Appropriations Committee of the House of Representatives by September 30, 2000, on how State-appropriated funds were expended for fiscal year 1999-2000 to reduce

the costs to Pennsylvania resident students or to provide services to Pennsylvania residents.

Section 6. This act shall take effect July 1, 1999, or immediately, whichever is later.

SB 502

Making appropriations to the Philadelphia Health and Education Corporation for the MCP Hahnemann University.

The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- Section 1. (a) The sum of \$6,106,500 is hereby appropriated to the Philadelphia Health and Education Corporation for the MCP Hahnemann University for the period January 1, 1999, to June 30, 1999, for instruction in the Doctor of Medicine program.
- (b) The sum of \$1,348,500 is hereby appropriated to the Philadelphia Health and Education Corporation for the MCP Hahnemann University for the period January 1, 1999, to June 30, 1999, for the general maintenance of the MCP Hahnemann University, including the Allied Health, Professions and Graduate School of the MCP Hahnemann University, and student aid.
- (c) The sum of \$240,750 is hereby appropriated to the Philadelphia Health and Education Corporation for the MCP Hahnemann University for the period January 1, 1999, to June 30, 1999, for minority educational and recruitment programs.
- (d) The sum of \$375,000 is hereby appropriated to the Philadelphia Health and Education Corporation for the MCP Hahnemann University for the period January 1, 1999, to June 30, 1999, for cardiovascular and heart failure/transplant studies.
- Section 2. (a) Payments to the Philadelphia Health and Education Corporation for the MCP Hahnemann University on account of the appropriations provided in section 1 shall be made twice during the six-month period by the Secretary of Education on the basis of costs during the six-month period.
- (b) The secretary shall not release the first payment unless the Trustees of the Philadelphia Health and Education Corporation for the MCP Hahnemann University have agreed in writing to include on its board a minimum of five members who are appointed by the Governor and designated officers of the General Assembly.
- (c) Upon receipt of the written agreement referred to in subsection (b), the Governor, President pro tempore of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives and the Minority Leader of the House of Representatives are authorized to each appoint an individual who is not an elected official to serve as a member of the board. The terms

of these members shall be coterminous with that of their respective appointing authorities.

Section 3. The Philadelphia Health and Education Corporation for the MCP Hahnemann University shall provide full, complete and accurate information as may be required by the Department of Education or the chairman or the minority chairman of the Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House of Representatives.

Section 4. The Philadelphia Health and Education Corporation for the MCP Hahnemann University shall report its revenues and expenditures and present its financial statements in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual (1975)" and the "Commonwealth of Pennsylvania Budget Instructions for the State System of Higher Education, State-Related Universities and Non-State-Related Colleges and Universities."

Section 5. The Trustees of the Philadelphia Health and Education Corporation for the MCP Hahnemann University shall report on forms provided by the Department of Education to both the chairman and minority chairman of the Appropriations Committee of the Senate and the chairman and minority chairman of the Appropriations Committee of the House of Representatives by September 30, 1999, on how State-appropriated funds were expended for fiscal year 1998-1999 to reduce the costs to Pennsylvania resident students or to provide services to Pennsylvania residents.

Section 6. The balance of the funds remaining unpaid under the act of May 7, 1998 (P.L.1496, No.21A), entitled "An act making appropriations to the Allegheny University of the Health Sciences," shall lapse on the effective date of this act.

Section 7. This act shall take effect immediately.

(a) Payments to the Thomas Jefferson University on account of the appropriations provided in section 1(a) and (b) shall be made quarterly by the Secretary of Education on the basis of costs during the fiscal year and shall be conditioned on continuing authority for inclusion on the Board of Trustees of the Thomas Jefferson University of a minimum of five individuals who are not elected officials and who are appointed, one each, by the Governor, the President pro tempore of the Senate, the Minority Leader of the Senate, the Speaker of the House of Representatives and the Minority Leader of the House of Representatives for terms of office coterminous with that of their appointing authority.
- (b) The Thomas Jefferson University shall provide full, complete and accurate information as may be required by the Department of Education or the chairman or the minority chairman of the Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House of Representatives.
- (c) The Thomas Jefferson University shall report its revenues and expenditures and present its financial statements in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual (1975)" and the "Commonwealth of Pennsylvania Budget Instructions for the State System of Higher Education, State-Related Universities and Non-State-Related Colleges and Universities."

Section 2. Payments to Lincoln University on account of the appropriations for the items provided in section 1 shall be made on the basis of costs during the fiscal year.

In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General shall have the right to review only, and he shall file annually with the General Assembly such information concerning said expenditures as the General Assembly or any of its committees may require.

- (iii) The number of different courses scheduled by level of instruction and the number of sections of individual instruction scheduled by level of instruction, each further subdivided by two-digit Classification of Instructional Program (CIP) categories of instructional programs of higher education as defined by the National Center for Education Statistics, United States Department of Education.
 - (iv) The number of terms scheduled and the dates thereof.
- (2) For the summer term and the following academic year in total and for each two-digit CIP program category, a classification of faculty members or other professional employees by title, including: professor, associate professor, assistant professor, instructor, lecturer, research associate, librarian and academic administrator; faculty members or other professional employees under each title to be subdivided by type of assignment: teaching and nonteaching; and each such set of faculty members or other professional

employees to be further subdivided by type of employment: full-time or parttime; and the following aggregates for each such subdivided classification:

- (i) The number of faculty and other professional employees and their fulltime equivalence in instructional and noninstructional functions.
- (ii) The sum of credits assigned to undergraduate classroom courses and the sum of credits assigned to graduate classroom courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.
- (iii) The sum of credits assigned to undergraduate individual instruction courses and the sum of credits assigned to graduate individual instruction courses taught, divided into lower division, upper division, master's, first professional and doctoral course levels.
- (iv) The sum of undergraduate classroom student credit hours and the sum of graduate classroom student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.
- (v) The sum of undergraduate individual instruction student credit hours and the sum of graduate individual instruction student credit hours generated, divided into lower division, upper division, master's, first professional and doctoral course levels.
- (vi) The total salary paid for instructional functions and for noninstructional functions and the amount of this salary paid for each of these functions from university funds, Federal funds and other funds.
- (3) For each term of the period covered for each faculty member employed full time identified by two-digit CIP program category and title, the report shall contain an analysis of the average hours per week spent in university-related activities, stating specifically hours spent in undergraduate classroom contact and graduate classroom contact, hours spent in preparation, hours spent in research and hours spent in public service.
- Section 6. In addition to the requirements in section 5 relative to this appropriation, the report covering the 12-month period beginning with the summer term 1999 shall include for all programs of the university:
- (1) Minimum number of credits required for a baccalaureate degree and for a master's degree.
- (2) Number of bachelor's degrees, master's degrees, first professional degrees and doctoral degrees awarded in 1995, 1996, 1997, 1998, 1999 and estimated 2000.
- Section 7. (a) The following words and phrases when used in this section shall have the meanings given to them in this subsection unless the context clearly indicates otherwise:

"Academic and administrative support units." Any organizational entity, as defined in the organizational manual of the university, that reports directly to the president of the university, chief academic officer or vice president, including the office of the president, chief academic officer and vice president.

"Expenditures." Disbursements of State appropriations, tuition and fees supporting educational and general categories as defined in the Higher Education Finance Manual, Department of Health, Education and Welfare, 1975, or disbursement, supported by State appropriations, tuition or fees, to support a defined project or program under subsection (b)(3).

"Revenue." All State appropriations and tuition and fees.

- (b) Lincoln University shall disclose the following:
- (1) Revenue and expenditure budgets of the university's academic and administrative support units for the current fiscal year.
- (2) The actual revenue and expenditures for the prior year in the same format as the information reported under paragraph (1).
- (3) For any defined project or program which is the subject of a specific line item appropriation from the General Fund, the university shall disclose the following:
- (i) Revenue and expenditure budgets of the defined program or project for the current fiscal year.
- (ii) The actual revenue and expenditures of the defined program or project for the prior year in the same format as the information reported under paragraph (1).
- (4) The revenue and expenditures of any auxiliary enterprise which is directly funded in whole or in part by tuition or a State appropriation for the current fiscal year.
- (c) The university shall provide the following additional information for the prior fiscal year for each academic or administrative support unit, for each defined project or program and for any auxiliary enterprise:
- (1) The number of employees by academic rank and by classification the number of administrators, staff, clerical and technical service employees.
- (2) Median and mean salary by academic rank and by classification the median and mean salaries of administrators, staff, clerical and technical service employees.
- (3) Nonsalary compensation as a percentage of salary. Nonsalary compensation shall include, but not be limited to, medical benefits, life insurance benefits, pension benefits, leave benefits, employer Social Security payments and workers' compensation benefits.
 - (4) A statement of the university's retirement policies.
- (5) A policy statement relating to a reduction of tuition for employees' family members.
- (6) A list of purchase of service contracts which exceed \$1,000 by category of service, including, but not limited to, legal, instructional, management, accounting, architecture, public relations and maintenance. The list shall contain the name and address of the contractor, a statement of the nature of the duties of the contractor and the academic and administrative support unit for which the duties are performed. If a purchase of service contract exceeds 10% of the total aggregate expenditure of the contract

category per academic or administrative support unit, then the contracted amount shall also be listed.

- (7) A list of purchase of goods contracts which exceed \$1,000. The list shall contain the name and address of the contractor and a list of the goods purchased and the academic or administrative support unit for which such goods were contracted. If a purchase of goods contract exceeds 10% of the total aggregate expenditure per academic or administrative support unit, then the contracted amount shall also be listed.
- (8) A list by academic or administrative support unit in the aggregate of the expenses of travel, subsistence and lodging, whether provided or reimbursed.
- (d) The university shall submit a report of the information under subsections (b) and (c) to the Education Committee of the Senate and the Appropriations Committee of the Senate and the Education Committee of the House of Representatives and the Appropriations Committee of the House of Representatives. In addition, the university shall submit a copy of the report to each of the following:
 - (1) Governor's Office.
 - (2) Secretary of Education.
 - (3) State Treasurer.
 - (4) Auditor General.
 - (5) Joint State Government Commission.

Each such institution shall maintain a copy of the report in the institution's library and shall submit a copy to each of the four State regional library resource centers.

- (e) A university's report required to be submitted under this section shall be submitted within 180 days of the close of the university's current fiscal year.
- (f) The Joint State Government Commission shall develop a statistical comparison analysis recognizing differences in missions from the reports made under this section. A majority of the members of the commission may request additional documentation, except for salary or identity of individuals, necessary to complete the comparative analysis. The comparison shall be provided to the Education Committee of the Senate and the Appropriations Committee of the House of Representatives and the Appropriations Committee of the House of Representatives and the four State regional libraries.
- (g) The university shall make a copy of the minutes of each public meeting of the institution's board of trustees as well as a copy of the institution's integrated postsecondary education data systems report available for public inspection in the institution's library.

The list shall contain the name and address of the contractor, a statement of the nature of the duties of the contractor and the academic and administrative support unit for which the duties are performed. If a purchase of service contract exceeds 10% of the total aggregate expenditure of the contract category per academic or administrative support unit, then the contracted amount shall also be listed.
- (7) A list of purchase of goods contracts which exceed \$1,000. The list shall contain the name and address of the contractor and a list of the goods purchased and the academic or administrative support unit for which such goods were contracted. If a purchase of goods contract exceeds 10% of the total aggregate expenditure per academic or administrative support unit, then the contracted amount shall also be listed.
- (8) A list by academic or administrative support unit in the aggregate of the expenses of travel, subsistence and lodging, whether provided or reimbursed.
- (d) The university shall submit a report of the information under subsections (b) and (c) to the Education Committee of the Senate and the Appropriations Committee of the Senate and the Education Committee of the House of Representatives and the Appropriations Committee of the House of Representatives. In addition, the university shall submit a copy of the report to each of the following:
 - (1) Governor's Office.
 - (2) Secretary of Education.
 - (3) State Treasurer.
 - (4) Auditor General.
 - (5) Joint State Government Commission.

Each such institution shall maintain a copy of the report in the institution's library and shall submit a copy to each of the four State regional library resource centers.

(e) A university's report required to be submitted under this section shall be submitted within 180 days of the close of the university's current fiscal year.

- (f) The Joint State Government Commission shall develop a statistical comparison analysis recognizing differences in missions from the reports made under this section. A majority of the members of the commission may request additional documentation, except for salary or identity of individuals, necessary to complete the comparative analysis. The comparison shall be provided to the Education Committee of the Senate and the Appropriations Committee of the Senate and the Education Committee of the House of Representatives and the Appropriations Committee of the House of Representatives and the four State regional libraries.
- (g) The university shall make a copy of the minutes of each public meeting of the institution's board of trustees as well as a copy of the institution's integrated postsecondary education data systems report available for public inspection in the institution's library.

Section 9. The University of Pittsburgh shall provide full, complete and accurate information as may be required by the Department of Education or the chairman or the minority chairman of the Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House of Representatives.

Section 10. The University of Pittsburgh shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual, United States Department of Health, Education and Welfare (1975)" and the "Commonwealth of Pennsylvania Budget Instructions for the State System of Higher Education, State-Related Universities and Non-State-Related Colleges and Universities."

- (d) The university shall submit a report of the information under subsections (b) and (c) to the Education Committee of the Senate and the Appropriations Committee of the Senate and the Education Committee of the House of Representatives and the Appropriations Committee of the House of Representatives. In addition, the university shall submit a copy of the report to each of the following:
 - (1) Governor's Office.
 - (2) Secretary of Education.
 - (3) State Treasurer.
 - (4) Auditor General.
 - (5) Joint State Government Commission.

Each such institution shall maintain a copy of the report in the institution's library and shall submit a copy to each of the four State regional library resource centers.

- (e) A university's report required to be submitted under this section shall be submitted within 180 days of the close of the university's current fiscal year.
- (f) The Joint State Government Commission shall develop a statistical comparison analysis recognizing differences in missions from the reports made under this section. A majority of the members of the commission may request additional documentation, except for salary or identity of individuals, necessary to complete the comparative analysis. The comparison shall be provided to the Education Committee of the Senate and the Appropriations Committee of the Senate and the Education Committee of the House of

Representatives and the Appropriations Committee of the House of Representatives and the four State regional libraries.

(g) The university shall make a copy of the minutes of each public meeting of the institution's board of trustees as well as a copy of the institution's integrated postsecondary education data systems report available for public inspection in the institution's library.

Section 9. Temple University shall provide full, complete and accurate information as may be required by the Department of Education or the chairman or the minority chairman of the Appropriations Committee of the Senate or the chairman or the minority chairman of the Appropriations Committee of the House of Representatives.

Section 10. Temple University shall report its revenues and expenditures and present its financial statements required under the provisions of this act in accordance with generally accepted accounting principles and procedures for educational institutions as set forth in the "Higher Education Finance Manual, United States Department of Health, Education and Welfare (1975)" and the "Commonwealth of Pennsylvania Budget Instructions for the State System of Higher Education, State-Related Universities and Non-State-Related Colleges and Universities."

The sum of \$2,000,000 is hereby appropriated from the General Fund to the American Battle Monuments Commission as a grant for use in the construction of the National World War II Memorial in the District of Columbia.
