CHAPTER MMCLXXIII.

An ACT to authorize and direct the commissioners of the county of Philadelphia, to sell and convey a certain piece of ground therein described, and for other purposes therein mentioned.

SECT. 1. BE it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That The com-the commissioners of the county of Philadelphia, be, and they are Philadelphia hereby authorized to sell and convey, all that part of the public empowered landing, situate on the west side of Front-street, and between No-ble and Duke-streets, in the township of the Northern-Liberties, in the landing in such manner and way, as a majority of the said commissioners and the Northern-Liberties. at least three of the Justices of the Peace of the said county, may ties. conceive will most conduce to the public interest; and to appropri-ate the proceeds of such sale, in the same manner as the neat proceeds of the rents of the public landings and wharves are appropriated by the third section of the act, entitled "An act respecting the public landings and wharves, in the township of the Northern-Lipublic landings and wharves, in the township of the two two there particular berties, in the county of Philadelphia," passed the fourth day of 274, chap. [Ante. pa. April, one thousand seven hundred and ninety-six.

CHAPTER MMCLXXIV.

An ACT for the relief of Peter Wikoff, Jonathan Bayard Smith, [See vol. 2, (note) and the act of 1st and others.

WHEREAS it has been represented to the Legislature, that (ch. 2587.)] Peter Wikoff, Jonathan Bayard Smith, and others, have received patents from this commonwealth, for certain tracts of land, in pursuance of surveys made before the north line of this state was ascertained by the commissioners appointed for that purpose, and that the said lands have fallen within the state of New-York : Therefore,

SECT. I. Be it enacted by the Senate and House of Representatives of the commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That Provision to the board of property upon application for that purpose, by Jonathan persons Bayard Smith, and Peter Wikoff, and others also, whose lands fell fall within within the State of New-York, on running the north boundary line the state of New-York, between this state and the said state of New-York, shall ascertain the amount of the payment made by them for the lands as aforesaid, and shall certify the same to the Receiver-General, who shall thereupon deliver a certificate or certificates of such sum, with interest thereon from the time of the payment, to the said Jonathan Bayard Smith, and Peter Wikoff, and others as aforesaid, and enter a credit in his book for the same, which may be transferred to any person, and passed as credit, either in taking out new warrants in any part of the state, where land may be found, or in payment of arrears of former grants.
