CHAPTER 100.

LAW ABOUT CARTWAYS.

Chap: 100 Be it &c: That each County-Court of this Province & territories therof shall appoynt and Settle Sufficient Cart-Ways to the most Convenient Landing-places in their Respective Countys, for publick use & benefit.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693, but accepted in Petition of Right, June 1, 1693, as chapter 52.

CHAPTER 101.

LAW ABOUT HOUSE OF CORRECTION.

Chap: 101 Be it &c That every County within this province of Pennsilvania and territories therunto belonging, shall befor the Last day of the 10th month next ensuing, att their own Cost & Charge, erect, build or Cause to be built in the most Convenient place in each county respectively a Sufficient house at Least 20 foot square for Restraint, Correction, Labour, & Punishment of all Such persons as shall be thereunto Committed by Law And that every County fayling herin shall forfeit and pay 40 pounds, to be Levyed on the goods and Chattells of the Inhabitants of Such County.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693, but accepted in Petition of Right, June 1, 1693, as chapter 53.

CHAPTER 102.

LAW ABOUT WEIGHTS AND MEASURES.

Chap: 102 And to prevent fraud in measures and to Reduce all foreign measures here to the English-Standard, Be it &c: That the

measures of this Province & territories therof, shall be according to the Standard of weights and measures in England, That is to say A Bushell shall Contain Eight Gallons, according to the Wine-chester-measure . . . And all weights to be Avoir-du-pois, which hath 16 Ounces to the pound, (Gold and Silver, only excepted) within 3 mos after the first Session of this General-Assembly.

Confirmed by chapter 154, 1684; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693, but accepted in Petition of Right, June 1, 1693, as chapter 54.

CHAPTER 103.

LAW PROHIBITING SALE OF UNMEASURED LIQUOR.

Chap: 103 And be it &c: That if any person shall, after the 24th day of the 4th Month, Export from, or Sell within this Province or territorys thereof, any Liquor or provision in any Cask, or Vessell, that is not gaged, and its measure marked, by an allowed gager in this Province &c: hee Shall forfeit the Same.

Confirmed by chapter 154, 1685; chapter 175, 1685; chapter 186, 1688; and chapter 191, 1690. Abrogated in 1693. Replaced by chapter 115, 1693.

CHAPTER 104.

LAW FIXING THE PRICE OF FLAX.

Chap: 104 Be it &c. For the Encouragement of all the Inhabitants of Pennsilvania, and territories thereunto belonging, to Sow, prepare & well dress hemp & flax therein for the marchant, That Such hemp shall be Current pay, betwixt man & man at 4 pence per pound & such flax at 8 pence per pound.

Confirmed by chapter 154, 1684; chapter 175, 1685; and chapter 186, 1688. Chapter 191, 1690 included it among the laws to be continued to the end of the next General Assembly and twenty days after and no longer. Abrogated in 1693. Replaced by chapter 97, 1693.
