Be it Enacted by &c: That the Chairges of each County shall be made up in open Court by the respective magistrats therof, And that every Such Court shall have, & hereby hath power to assess & Lay such Taxes upon the County as shall defray the same so that it be equall & according to proportion, And that the one half of the Said Tax to be paid, shall be raised upon Land, the other half by the poll, on the Male from Sixteen to Sixty years of age... And that all such persons who hold Land within the said province & territories therof, and doe not reside therin, & so Uncapable of giving that attendance & yeelding that Service to the publick as those that Live therin, shall pay to all publick taxes for such Lands so holden by them, one half more than Residents pay for the same proportion.

CHAPTER 128.

LAW ABOUT COMPENSATION OF PUBLIC OFFICERS.

Chap: 128 And to the end that the requisit Charges of the government may be defrayed, and that persons thought fit to Serve the publick therein may in Some measure be Supported & encouraged to discharge their trust with Care & diligence Be it &c: That every member chosen or to be chosen to Serve in Provincial-Council, shall be & is hereby allowed 3 shillings and 6 pence by the day, during his attendance, And every member chosen or to be chosen to serve in Assembly, Shall have & is hereby allowed 3 shillings by the day, during his attendance on the service of the Assembly, And the Speaker of the said Assembly 3 shillings & 6 pence by the day during the time the Assembly shall Continue together . . . And that each member of the Provincial-Council & Assembly aforesaid shall be allowed towards their travelling Chairges, at the rate of 2 pence a mile, bothe going to, and Coming from the place where the Provincial Council & Assembly is or shall be held.
