Be it enacted by the authority aforesaid, That each County-Court of this Province and Territories thereof shall appoint and settle sufficient Cart-ways to the most convenient Landing places in their respective Countys for public use and benefit.

## CHAPTER 53.

[53] THE LAW ABOUT HOUSE OF CORRECTION.

Be it enacted by the authority aforesaid that every County within this Province of Pensilvania and Territories thereunto belonging, shall before the last day of the tenth month next ensuing at their own Cost and Charge erect, build, or cause to be built in the most convenient place in each County repsectively a sufficient house at least 20 foot square for Restraint Correction, Labour & punishment of all such persons as shall be thereunto Committed by Law, And that every County failing herein shall forfeit and pay 40 pounds to be Levyed on the goods & Chattells of the Inhabitants of such County.

# CHAPTER 54.

[54] THE LAW ABOUT WEIGHTS & MEASURES.

And to prevent fraud in Measures, and to reduce all forreign measures here to the English Standard — Be it Enacted by the Authority aforesaid, That the Measures of this province & territories thereof, shall be according to the Standard of Weights and Measures in England — That is to say, a bushel shall Contain eight gallons, according to the Winchester measure And all weights to be Avoirdupois, which hath sixteen ounces to the pound (gold & Silver only excepted), within three moneths after the first Sessions of this Generall Assembly.

## CHAPTER 55.

[55] THE LAW ABOUT DEPARTERS OUT OF THE PROVINCE.

Be it Enacted by the Authority aforesaid That every person intending to depart or Leave this Province & Territories thereof, shall publish his or her intention in writing affixed on the door of the County Court, where hee or shee inhabits, thirty days before his or her departure & shall have a pass under the County Seal — And if any Master of Ship or Vessel or others shall presume to Convey or transport any person out of this Province or territories thereof, without such pass, shall pay the damages that shall happen thereby.

## CHAPTER 56.

#### [56] THE LAW ABOUT BUYING LAND OF NATIVES.

Be it Enacted by the authority aforesaid, That if any person shall presume to buy any Land of the Natives in the Limits of this province or territories thereof, without Leave from the Proprietary & Governour thereof, or his deputy, such person shall Lose the said Land, and pay at the rate of ten shillings for every hundred acres thereof, to the Governour or his Assigns.
