ing for such purposes as may have affinity with the design of their institution, and for no other.

Provided, That the issues or profits arising from such parts of the building shall be applied to the purposes for which the said society was originally instituted, and to no other, anything in the act to which this is a supplement to the contrary notwithstanding.

CHAPTER MCCXIV.

AN ACT FOR REPEALING SO MUCH OF A LAW PASSED IN DECEMBER ONE THOUSAND SEVEN HUNDRED AND EIGHTY FOR RAISING THE SUM OF NINETY-THREE THOUSAND SIX HUNDRED AND FORTY POUNDS TEN SHILLINGS ANNUALLY FOR SIX YEARS AS RELATES TO THE PAYMENTS OF THE LAST FOUR ANNUAL TAXES THEREIN' DIRECTED TO BE LAID.

(Section I. P. L.) Whereas in and by an act passed the nineteenth day of December, one thousand seven hundred and eighty, entitled "An act for funding and redeeming the bills of credit of the United States of America and for providing means to bring the present war to a happy conclusion,"¹ it was directed and provided that the sum of ninety-three thousand six hundred and forty pounds ten shillings should be annually raised, levied and paid for six succeeding years for the purpose of redeeming the bills of credit emitted in consequence of the resolution of congress of the eighteenth day of March, one thousand seven hundred and eighty:

And whereas no more than two yearly requisitions thereof have been paid throughout the state:

And whereas the redemption of the said bills emitted on the faith of this state is fully provided for by the taxes heretofore laid and the other means already provided:

And whereas it is the duty of the legislature as much as possible to diminish the burden of the good citizens of this state:

Therefore;

[Section I.] (Section II. P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That so much of the act aforesaid and no more as relates to the raising, levying and discharging the last four annual taxes therein directed to be paid shall be and the same is hereby repealed, annulled and declared to be void, anything contained in the said act to the contrary notwithstanding.

CHAPTER MCCXV.

AN ACT TO REPEAL AN ACT ENTITLED "AN ACT TO SUSPEND AN ACT OF GENERAL ASSEMBLY OF THIS COMMONWEALTH ENTITLED 'A SUPPLEMENT TO AN ACT ENTITLED "AN ACT TO ENABLE WIL-LIAM CLINGAN, THAMAS BULL, JOHN KINKEAD, ROGER KIRK, JOHN SELLERS, JOHN WILSON AND JOSEPH DAVIS TO BUILD A NEW COURT HOUSE AND PRISON IN THE COUNTY OF CHESTER AND TO FELL THE OLD COURT HOUSE AND PRISON IN THE BOROUGH OF CHESTER." "1

(Section I. P. L.) Whereas by the said suspending law it is recited that a general dissatisfaction and uneasiness did prevail and subsist among the good people of the county of Chester with the said act and the intended removal of the seat of justice from the borough of Chester to the Turk's Head in Goshen township in the same county:

And whereas it appears from a variety of petitions, remonstrances and memorials presented to and laid before the present house of Assembly that a great part of the good people of said county are much dissatisfied with the courts of justice remaining at the borough of Chester, and it being just and reasonable
