CHAPTER MCDLXXXIII.

AN ACT TO REPEAL PART OF THE ADDITIONAL SUPPLEMENT TO THE ACTS FOR THE REGULATION OF THE MILITIA OF THIS COMMON-WEALTH.

(Section I, P. L.) Whereas it has been found on experience that the second section of the additional supplement to the acts for the regulation of the militia of this commonwealth passed the twenty-second day of March, one thousand seven hundred and eighty-eight authorizing the lieutenants of the city and county of Philadelphia and the several counties within this commonwealth to furnish the officers commanding battalions or corps with thirteen cartridges for every militia-man actually bearing arms in each battalion or corps on every battalion day hath not been productive of the advantages expected from it but on the contrary is found unnecessarily expensive:

Therefore:

[Section I.] (Section II, P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That so much of the additional supplement to the acts for the regulation of the militia of this commonwealth as authorizes or directs the city and county lieutenants to furnish the militia with cartridges on battalion days shall be and is hereby repealed.

CHAPTER MODLXXXIV.

AN ACT TO DIVIDE THE COUNTY OF FAYETTE INTO ELECTION DISTRICTS.

(Section I, P. L.) Whereas by the eighteenth section of the constitution it is provided that each county at its own choice

may be divided into districts, hold elections therein and elect their representatives in the county and their other elective officers, and as a division of the county of Fayette would contribute to the ease and convenience of the good citizens thereof in holding their annual elections:

[Section I.] (Section II, P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That from and after the enacting hereof the elections of the county of Fayette which is hereby divided into four districts shall be held in four places, to wit, the freemen of the townships of Union, Franklin and Wharton, the first district, shall hold their elections at the court-house in Uniontown; the freemen of the townships of Springhill, German and George's, the second district, shall hold their elections at the house now occupied by Nicholas Riffle in German Township [aforesaid]; the freemen of the townships of Luzerne, Manallen and Washington, the third district, shall hold their elections at Fort Burd; and the freemen of the townships of Tyrone and Bulskin, the fourth district, shall hold their elections at the house now occupied by Samuel Hicks in Bulskin township aforesaid anything in the act entitled "An act to regulate the general elections of this commonwealth and to prevent frauds therein," contained to the contrary in anywise notwithstanding.

CHAPTER MCDLXXXV.

AN ACT TO COMPENSATE WILLIAM LYON, ESQUIRE.

(Section I, P. L.) Whereas it appears to this house that the dwelling house and office of William Lyon, Esquire, prothonotary of the county court of common pleas for the county of Cumberland, having caught fire on the night of the first day of April one thousand seven hundred and eighty-nine were to-
