

## CHAPTER MODXCIX.

## AN ACT FOR THE RELIEF OF JOHN LYTLE, JOHN WEBB AND WILLIAM MURRAY.

(Section I, P. L.) Whereas John Lytle, John Webb and William Murray by their petitions have represented to this house that they in order to improve their farms borrowed money from the loan office in the year one thousand seven hundred and seventy four and that in the late Indian war they were driven from their habitation and lost all their personal property, by which means they are rendered at this time unable to discharge the several sums due by them to the state and have prayed this house to grant them a longer time to discharge the same:

And whereas it is just and reasonable that the prayer of their petition should be granted:

Therefore:

[Section I.] (Section II, P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That no further proceedings shall be had against John Lytle, John Webb and William Murray for five years from and after the enacting hereof.

## CHAPTER MD.

## AN ACT FOR COMPENSATING LAUGHLIN McCARTNEY AND OTHERS THEREIN MENTIONED FOR SUPPLIES BY THEM FURNISHED THE CIVIL OFFICERS OF NORTHUMBERLAND COUNTY IN THE YEAR ONE THOUSAND SEVEN HUNDRED AND SEVENTY-FIVE.

(Section I, P. L.) Whereas Laughlin McCartney, John Simpson, Thomas Gaskins, William Sayers, William McKim, Fred-

erick Stone, Aaron Levy, Robert Martin and William Mackey by their petition to this house have represented that in consequence of the orders of John Penn, Esquire, late Governor of Pennsylvania to enforce the execution of the laws in the county of Northumberland dated the twenty fifth day of November one thousand seven hundred and seventy-five they furnished sundry supplies to the persons employed to execute the said orders and as the said accounts cannot be settled and adjusted under any of the existing laws of this commonwealth and as it is just and reasonable that compensation should be made to those who furnished supplies for the use of government:

Therefore:

[Section I.] (Section II, P. L.) Be it enacted and it is hereby enacted by the Representatives of the Freemen of the Commonwealth of Pennsylvania in General Assembly met and by the authority of the same, That the comptroller-general of this state be and he is hereby authorized and required to examine and settle the said accounts admitting them or such parts of them as appear to be just and equitable and the same being examined and approved by the register-general and afterwards confirmed by the president and supreme executive council and thereupon issue certificates in favor of the said Laughlin McCartney, John Simpson, Thomas Gaskins, William Sayers, William McKim, Frederick Stone, Aaron Levy, Robert Martin and William Mackey for such sums as they shall respectively be entitled to which certificates shall bear interest from the first day of January one thousand seven hundred and eighty-five.
