Section III. (Section III, P. L.) And be it further enacted by the authority aforesaid, That Redman Cunningham, Henry Donnell and George Haines or any two of them, be, and they are hereby appointed commissioners to run and mark the said line contemplated by this act, and return a copy of the same into the prothonotary's office of each county, for which services they shall receive at the rate of two dollars per mile for the whole distance, with reasonable expenses for chain carriers and axemen, to be paid by warrants drawn by the commissioners of Luzerne county, on the treasurer of said county.

CHAPTER MMCMLXXXIX.

AN ACT TO CONTINUE AN ACT, ENTITLED "AN ACT TO PROVIDE FOR THE INSPECTION OF GROUND BLACK OAK BARK, INTENDED FOR EXPORTATION." (*).

Section I. (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the act, entitled "An act to provide for the inspection of ground black oak bark intended for exportation," passed the third day of April, one thousand eight hundred and four, and every matter therein contained, (except the limitation thereof,) be, and the same is hereby continued in force for and during the term of four years, and until the end of the session of the legislature, then next ensuing and no longer.

CHAPTER MMCMXC.

AN ACT FOR THE RELIEF OF JOHN M'CONAHEY.

Section I. (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted

by the authority of the same, That the said John M'Conahey, be, and he is hereby allowed the sum of sixty-four dollars, to be paid on a warrant drawn by the governor out of any unappropriated monies in the treasury of this commonwealth.

CHAPTER MMCMXCI.

AN ACT FOR THE RELIEF OF MARY BACKHOUSE.

Whereas it appears that Richard Backhouse, late of Bucks county, purchased in the years one thousand seven hundred and seventy-nine, and one thousand seven hundred and eighty, for a valuable consideration, several tracts of land in said county, of George Wall, the commissioner of confiscated estates, for the natural life of Joseph Galloway, in virtue of an act of Assembly, for the attainder of the said Galloway: And whereas Mary Backhouse, widow and relict of the said Richard Backhouse, was evicted from the said tracts of land by a judgment of the supreme court, and in the lifetime of the said Galloway; that after the judgment aforesaid, an action was commenced against the said Mary Backhouse, for mesne profits, and a verdict given for the same together with costs of suit: Therefore,

Section I. (Section I, P. L.) Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania, in General Assembly met, and it is hereby enacted by the authority of the same, That the governor of this commonwealth be, and he is hereby authorized to draw his warrant on the state treasurer, in favor of Mary Backhouse, for four hundred and fifteen dollars, to be paid out of any unappropriated money in the treasury, in full compensation for losses sustained in defending the aforesaid action.
